SECURITIES AND EXCHANGE COMMISSION SUSPENDS TRADING IN SAFE TRANSPORTATION SYSTEMS, INC. FOR FAILURE TO MAKE REQUIRED PERIODIC FILINGS

The U.S. Securities and Exchange Commission announced the temporary suspension of trading of the securities of Safe Transportation Systems, Inc. (SFTP), commencing at 9:30 a.m. EDT on January 19, 2006 and terminating at 11:59 p.m. EDT on February 1, 2006:

The Commission temporarily suspended trading in the securities of SFTP due to a lack of current and accurate information about the company because it is delinquent in its periodic filing obligations under Securities Exchange Act of 1934 (Exchange Act) Section 13(a). This order was entered pursuant to Exchange Act Section 12(k).

The Commission cautions brokers, dealers, shareholders and prospective purchasers that they should carefully consider the foregoing information along with all other currently available information and any information subsequently issued by the company.

Brokers and dealers should be alert to the fact that, pursuant to Exchange Act Rule 15c2-11, at the termination of the trading suspension, no quotation may be entered relating to the securities of the company unless and until the broker or dealer has strictly complied with all of the provisions of the rule. If any broker or dealer is uncertain as to what is required by the rule, it should refrain from entering quotations relating to the securities of the company that has been subject to this trading suspension until such time as it has familiarized itself with the rule and is certain that all of its provisions have been met. If any broker or dealer enters any quotation which is in violation of the rule, the Commission will consider the need for prompt enforcement action.
