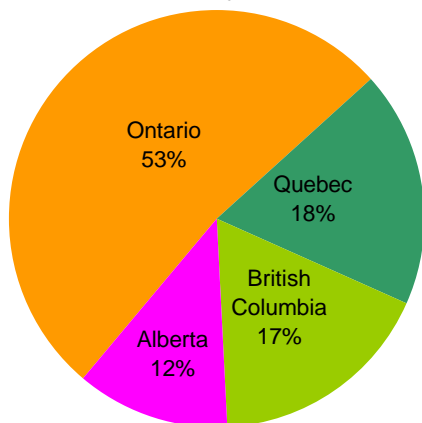

- ▶ Canadian architects regularly form alliances with small and medium sized U.S. firms to respond to operational challenges.
- ▶ To date, forty-five U.S. States and all ten Canadian provinces have agreed on a framework to grant reciprocal privileges in licensing their respective architects.

MAJOR UPCOMING PROJECTS

Project opportunities vary within each province or territory and may be driven by funding provided by all Canadian government levels for specific infrastructure development or by major opportunities like the 2010 Olympic and Paralympic Games in Vancouver, British Columbia. Total construction projects directly associated with the 2010 Games are estimated at approximately US\$1.6 billion. In addition, the Games are acting as a catalyst for economic activity in British Columbia, providing additional opportunities valued at approximately US\$7 billion.

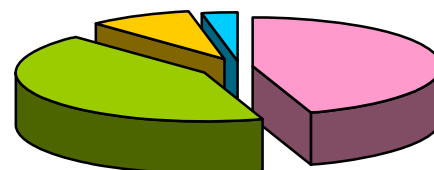
MARKET OVERVIEW

- ▶ The Canadian architectural services sector generated operating revenues of US\$1.5 billion in 2006, an increase of 2.7% from the previous year.
- ▶ According to the Royal Architectural Institute of Canada, there are approximately 14,300 people employed by this sector, of which more than 7,000 are registered/licensed architects.
- ▶ The business sector accounts for 45% of architectural revenues, followed by government clients (43%); 9% from individuals and 3% from foreign clients.

COMPETITORS

- ▶ More than 4,600 architectural establishments dominate the Canadian architectural market operating primarily on a local basis. Most of these have 1-3 employees and there are only 10-15 large firms with 50-100 employees. Numerous Canadian firms are also active abroad.
- ▶ Ontario has the largest representation of Canadian architectural firms
- ▶ The nature of projects undertaken by Canadian architects varies by geographic region and size of firm.
