**SECURITIES AND EXCHANGE COMMISSION INSTITUTES
ADMINISTRATIVE PROCEEDINGS AGAINST SEVENTEEN DELINQUENT
COMPANIES FOR FAILURE TO MAKE REQUIRED PERIODIC FILINGS**

The U.S. Securities and Exchange Commission today instituted three separate public administrative proceedings against a total of seventeen companies to determine whether the registration of each class of their securities should be revoked or suspended for a period not exceeding twelve months for failure to file required periodic reports:

In this proceeding, the Commission instituted administrative proceedings against the following issuers:

In this proceeding, the Commission instituted administrative proceedings against the following issuers:

- Integrated Communication Networks, Inc. (ICNW)
- Keystone Energy Services, Inc. (KESE)

In each of these proceedings, instituted pursuant to Securities Exchange Act of 1934 (Exchange Act) Section 12(j), a hearing will be scheduled before an Administrative Law Judge. At the hearing, the judge will hear evidence from the Division and the respondents to determine whether the allegations of the Division contained in the Order, which the Division alleges constitute failures to comply with Exchange Act Section 13(a) and Rules 13a-1 and 13a-13 thereunder, are true. The judge in the proceeding will then determine whether the registrations pursuant to Exchange Act Section 12 of the securities of these respondents should be revoked, or in the alternative, suspended for a period not exceeding twelve months. The Commission ordered that the Administrative Law Judges in these proceedings issue an initial decision not later than 120 days from the date of service of the order instituting proceedings.
