

Procurement Procedures


The Procurement Guidelines, posted on MCC Website <u>www.MCC.gov</u> defines the principles, rules and procedures for all procurements.

Procurement Guidelines govern the conduct and administration by MCAs of the procurement of the goods, works, consultant and non- consultant services

✤ General procurement notices published on the MCC Website, MCA website, DGMarket and UNDBOnline websites

- Contracts awarded to qualified and capable contractors
- Performed in accordance with the terms and conditions
- Cost-effective and timely
- ✤ No more than a commercially reasonable price

MCC Program Procurement Guidelines



Based on World Bank Procurement Guidelines with Key Exceptions:

- No Geographic Preferences
- US Prohibited Sources ineligible
- US or Local Currency only
- Required Use of English Language
- Low Advertising Thresholds

Types of Payment Mechanisms

- 1. Partial Payments
 - Multiple payments
 - Partial Performance
 - Reports
 - Work Complete
 - Other Deliverables
 - Mobilization
 - Final Payment
- 2. Advance Payments
 - Large works, some small works and custom goods
 - Requires justification and advance payment guaranty
 - Early payments for major consultants
- 3. Progress Payments
 - Used under reimbursable cost contracts
