



Economic Snapshot

- Strong economic growth, in excess of 7%, is expected to continue.
- Scaling up of government investment coupled with generous donor support, and improvement in energy and transport infrastructure enhance productivity.
- High oil prices remain a risk to the inflation outlook.
- Metical will continue to be supported by donor inflows, FDI and export revenue.
- Concerted efforts by authorities to improve business environment should attract investment supporting diversification initiatives.
- In the construction industry, large infrastructure projects and mining investments contribute to 11.8% y/y growth in the industry

Centro de Promoção de Investimentos (CPI)

- CPI is a Government body to promote and assist investors.
- Minimum direct investment (investor's own capital investment) is USD 50,000 for foreign investors.
- Foreign investors who comply with the minimum amount of direct investment are allowed to remit profits out of the country.

Business Vehicles

- No restrictions on foreign individuals or entities to set up business in Mozambique.
- Two main forms of limited liability entity available under Mozambican Commercial Law: a branch or a limited company.

Registering a branch:

- Branches have to be registered with Ministry of Commerce and Industry.
- Objective of a branch is to execute a specific contract and the activities permitted under the license granted are restricted to the contract (s). The license is valid for three years, renewable.
- A branch is more appropriate for short duration ventures.

Incorporation of limited liability company:

 Most commonly used limited liability Mozambican business are Sociedade por Quotas (Limitada = private companies) and Sociedade Anónima de responsabilidade Limitada (SA = public companies)

Operating License

 All companies require an operating license ("Alvará"), and it is normally not complicated to obtain.

 Civil construction business have specific requirements (e.g. financial capacity; minimum technical staff)

Taxation

Direct taxes

These consist of

- (A) Individual Income Tax (IRPS)
- (B) Corporate Income Tax (IRPC)

Other taxes

Indirect Taxes - e.g. Value Added Tax (IVA)

Municipality Taxes – e.g. Personal Municipal Tax

Double Taxation Treaty

A DTT between Mozambique and South Africa has been signed but not yet ratified by the two parliaments.

This will have significant effects on investors' choice of the optimum investment structure.

Value-Added Tax

Main aspects of Mozambique VAT

- VAT is levied on the supply of goods or services
- Mozambique's VAT rate is 17%
