

Why Colombia?

Colombia is one of the most stable economies in Latin America, as shown by its above average steady economic growth. The inflation rate has been substantially reduced over the last few years to reach low single digits. Foreign debt has been reduced by more than 20% of the GDP in the past few years. Colombia's workforce is considered to be the best within the Andean Community, and one of the most qualified, at management level, in Latin America. The literacy rate in Colombia is 94.2%, one of the highest rates in Latin America. Colombia is known as the Latin American oldest and most stable democracy attracting over 700 multinational companies.
