NOTICE THAT INITIAL DECISION HAS BECOME FINAL

The time for filing a petition for review of the initial decision in this proceeding has expired. No such petition has been filed by C.R. Williams, Inc., and Charles Russell Williams II, and the Commission has not chosen to review the decision as to them on its own initiative.

Accordingly, notice is hereby given, pursuant to Rule 360(d) of the Commission's Rules of Practice, 1/ that the initial decision of the administrative law judge 2/ has become the final decision of the Commission with respect to C.R. Williams, Inc., and Charles Russell Williams II. The orders contained in that decision are hereby declared effective. The orders required C.R. Williams, Inc., and Charles Russell Williams to cease and desist from committing or causing any violations or any future violations of Section 203A and 204 of the Investment Advisers Act of 1940 and Advisers Act Rules 203A-1(b)(2), 204-1(a)(1), 204-2(a)(1), 204-2(a)(2), and 204-2(a)(6); revoked the investment adviser registration of C.R. Williams, Inc.; barred Charles Russell Williams from association with an investment adviser; and further ordered a civil money penalty in the amount of \$10,000 to be paid jointly and severally by C.R. Williams, Inc., and Charles Russell Williams.

Payment of the civil penalty shall be made within 30 days of this notice by certified check, United States Postal money order, bank cashier's check, or bank money order, payable to the U.S. Securities and Exchange Commission. The payment, and a cover letter identifying
