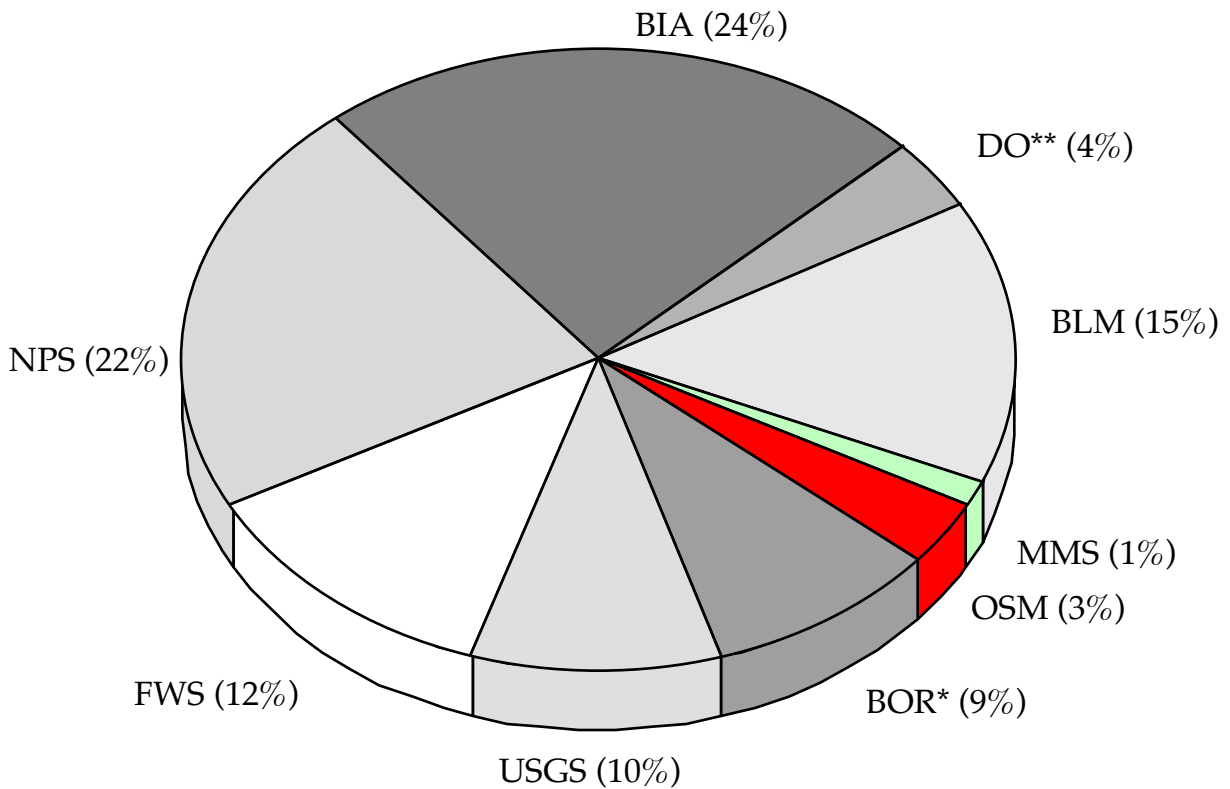


BUREAU HIGHLIGHTS
