MOTION FOR EXTENSION OF TIME OF JOINT CONSUMER PETITIONERS

Pursuant to Rule 1.46, the Joint Consumer Petitioners request an extension of one week to reply to the *Opposition to Petition to Deny* filed by Comcast Corporation and AT&T Corp. (Applicants) on May 21, 2002. If the Bureau grants this *Motion*, Joint Consumer Petitioners will have until June 5, 2002, to file a timely *Reply* to Applicants' *Opposition*.

On April 29, 2002, in accordance with 47 CFR §1.45 and 47 CFR §1.939, the Joint Consumer Petitioners filed a timely *Petition to Deny* the above captioned application. *See Petition to Deny of Arizona Consumers Council, et al.* filed April 29, 2002. Applicants were initially required to file their *Opposition* to this petition on May 14, 2002. *See Public Notice,* released March 29, 2002. On May 1, 2002, Applicants filed a motion under 47 CFR §1.46 for an extension of one week. The Media Bureau granted the motion on May 3, 2002.

Applicants timely filed their "Reply to Comments and Petitions to Deny" on May 21, 2002. Accordingly, replies to this *Opposition* to Joint Consumer Petitioner's *Petition* are due on May 29,

2002. See 47 CFR §1.45(c).

Joint Consumer Petitioners request an extension of one week, i.e., until June 5, 2002.

Applicants filed a lengthy *Opposition*, and it will take Joint Consumer Petitioners additional time

to reply. Furthermore, the reply period is taken up in large part by the Memorial Day weekend

holiday. Joint Consumer Petitioners have only a small staff, and it would create considerable

hardship to require them to work over the Memorial Day weekend.

Joint Consumer Petitioners observe that the Bureau granted the Applicants' extension

request on the grounds that granting an extension would further development of the record and not

unduly delay this proceeding. Grant of this identical request to Joint Consumer Petitioners would

likewise serve that purpose without delaying this proceeding.

WHEREFORE, Joint Consumer Petitioners request that the Bureau extend the deadline for

replies to the *Opposition* filed by Applicants by one week to June 5, 2002.
