In compliance with **Title 43 Code of Federal Regulations, Section 9212.2** and to prevent wildfire during severe burning conditions, the following acts are prohibited on Public Lands within the Bureau of Land Management's Palm Springs-South Coast Field Office jurisdiction beginning August 14, 2007 at 1200 p.m., and continuing until further notice:

#### Whitewater Closure: Order Number CA-660-07-01

The following is prohibited on federal lands unless otherwise noted:

1. It is illegal to enter and be upon public lands that are described and identified as the "Fire Closure Area" in Exhibits A and B, attached to and made part of this order. Exhibit A and B are the map and legal description of the Fire Closure Area, respectively. Violation of this order is punishable by a fine of not more than \$1,000 or imprisonment for not more than 12 months, or both. (*Title 43, C.F.R. §9212.4*)

### **Exemptions**:

Pursuant to 43 CFR §9212.2, the following persons are exempt from this order.


- a. Persons with a permit from or contract with the BLM that specifically authorizes the otherwise prohibited act.
- b. Owners or lessees of land in the area for the purpose of accessing that land.
- c. Residents in the area for the purpose of accessing their residence.
- d. Persons engaged in a business, trade, or occupation in the area requiring passage thru or upon BLM land in order to conduct such business, trade or occupation.
- e. Any other person meeting exemption or requirements specified in the order.
- f. Persons with a permit specifically authorizing the otherwise prohibited act.
- g. Any Federal, State, or local Officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- h. Hikers utilizing the Pacific Crest Trail when in compliance with all other applicable fire restrictions and orders. (identified on attached map)

The area, roads, and trails affected by this order are a combination of BLM public lands, private lands and conservancy lands within the boundaries of the Palm Springs-South Coast Field Office, Bureau of Land Management. For information call (760) 251-4800

## Order No. CA-660-07-01 <u>Description of Fire Restriction Areas</u>

The public lands, within the area described as the Whitewater Canyon area and located within Township 3 South., Range 3 East., Sections 15,22,23,26,34 and 35 Township 3 South., Range 3 East., Sections 2, 11 and 12 all located in the San Bernardino Base and Meridian will be temporarily closed to entry and all use by the public. This order closes approximately 4,234 acres of public lands.
