Terms of payment

The stand rent, plus the appropriate VAT, has to be paid in three instalments, in accordance with the provision of clause 6 of the General Rules as follows:

1. Registration fee direct after receiving confirmation of participation;
2. Advance invoice of 25% of the charge of the floor area applied for: within 21 days of the date of the advance invoice (these invoices will be sent to the exhibitors from 365 days before the exhibition onwards);
3. Final invoice of 100% (minus 25% of the advance invoice): within 21 days of the date of the final invoice confirming the allocation of stand space (these invoices will be sent from 60 days before exhibition onwards).

From 60 days before the show and onwards no advance invoices will be sent anymore. If the application of stand space is made less than 60 days before the first day of construction of the exhibition, the appropriate amount must be paid simultaneously with the application and must have been paid in full within 4 days before the actual construction starts.
