**National Children Study**

The study will examine the effects of environmental influences on the health and development of more than 100,000 children across the United States, following them from before birth until age 21. The goal of the study is to improve the health and well-being of children. Preliminary results from the first years of the study will be available in 2009-2010.

The study defines "environment" broadly and will take the following issues into account:

- Natural and man-made environment factors
- Biological and chemical factors
- Physical surroundings
- Social factors
- Behavioral influences and outcomes
- Genetics
- Cultural and family influences and differences
- Geographic locations
