Attached is an application to be listed, free of charge, in the Indian Arts and Crafts Board's *Source Directory of American Indian and Alaska Native Owned and Operated Arts and Crafts Businesses*.

The *Source Directory* promotes federally recognized American Indian and Alaska Native artists and craftspeople, cooperatives, and tribal arts and crafts enterprises. Listings include businesses privately owned and operated by Indian artists, designers and craftspeople, as well as businesses privately owned and operated by Indian merchants who retail and/or wholesale authentic Indian arts and crafts. Also included are several nonprofit organizations that work directly with Indian groups to develop and market arts and crafts products.

The *Source Directory* may be viewed on the Indian Arts and Crafts Board web site, [www.iacb.doi.gov](http://www.iacb.doi.gov). Your listing in the directory will serve as a direct link between your business and potential customers.

**For your application to be considered, it must include the following:**

1. **Business information, including contact and product information.** *See enclosed sample format and suggestions.* Please note that although you are not required to have a shop location readily available to the public, the business must then be prepared to complete sales through a website, mail order or a comparable method.
2. **Business, manager, and owner names.** You must also include the name of the federally recognized Tribe(s) or Alaska Native Village(s) of which the manager and owner are enrolled.
3. **CERTIFICATION.** The business owner is required to sign the application, on the designated line, certifying that he or she is the owner of the business and is an enrolled member of a federally recognized American Indian Tribe or Alaska Native Village.
4. **Photocopy of tribal enrollment documentation** from the business owner's respective federally recognized American Indian Tribe or Alaska Native Village.

This information is required for a business to be listed in the *Source Directory*. Also, if you have a price list, catalog, or other printed information about your business, please send it with your application. The Indian Arts and Crafts Board will include it in its reference files for use in answering product inquiries.
