B. SYSTEM APPLICATION/GENERAL INFORMATION:

Datamart provides two applications to support the analysis of FPPS (Federal Personnel and Payroll System) and FFS (Federal Financial System) data. The two applications are the FPPS Datamart and the FFS Data Warehouse.

1) Does this system contain any personal information about individuals?

Yes.

The Datamart application may contain the following personal information about individuals. Please note, this list provides examples, but is not exhaustive:

a. Is this information identifiable to the individual?

Yes. The information in the Datamart is identifiable to the individual.

b. Is the information about individual members of the public?

Yes. The information in the Datamart may be about members of the public if the individual is an emergency worker, volunteer, contractor, retired federal employee, designated as an Emergency Contact or an employee or volunteer or a vendor (may be an individual, small or large business.)

c. Is the information about employees?

Yes. The information in the Datamart is about employees of the Federal Government. Therefore, this PIA is included as part of the DOI IT Security C&A process and the OMB Exhibit 300.

2) What is the purpose of the system/application?

The purpose of the Datamart is to provide end users the ability to query, analyze, chart and report on FPPS and FFS data. The Datamart provides a library of pre-formatted queries, plus the ability to create and run ad-hoc queries. The pre-formatted queries enable FPPS and FFS users to get timely information from the Datamart and produce reports. The end-user can also export this information to many formats for processing elsewhere. Direct access to this data for other applications can be configured through secure, direct connections to the underlying Oracle database.

3) What legal authority authorizes the purchase or development of this system/application?

The legal authority for the Datamart application is defined in the Office of Management and Budget Circular A-127, Policies and Standards for Financial Management Systems. This Circular is issued pursuant to the Chief Financial Officers Act (CFOs Act) of 1990, P.L. 101-576 and the Federal Managers' Financial Integrity Act of 1982, P.L. 97-255 (31 U.S.C. 3512 et seq.); and 31 U.S.C. Chapter 11.

C. <u>DATA in the SYSTEM:</u>

1) What categories of individuals are covered in the system?

Categories of individuals covered in the Datamart application include employees, emergency workers, contractors, retired federal employees, government corporations, commissions, panels, councils, and foundations, volunteers of executive branch and independent agencies, and emergency contacts for employees and volunteers.

The Datamart application contains information about employees under a wide range of pay authorities covering individuals under the General Pay Schedule, Title 4 (National Park Service Law Enforcement), Title 5 (Government Organization and Employees), Title 6 (Bureau of Indian Affairs Contract Educators), OPM-approved pay plans, and public laws unique to FPPS application clients (e.g., Presidio Trust, Casuals, Overseas Private Investment Corporation, Securities and Exchange Commission, and Department of Transportation) USC Title 31 (Money and Finance) pertains to employees and vendors in the FFS system.

2) What are the sources of the information in the system?

a. Is the source of the information from the individual or is it taken from another source? If not directly from the individual, then what other source?

The information in the Datamart application is received from the following sources:

- The personal information on each individual is provided through interface files and other interface methods from the FPPS application.
- Financial data is provided from the FFS application.
