# U.S. Companies Establish Healthcare Forum in Egypt

On June 20<sup>th</sup>, Commercial Service Egypt hosted an executive roundtable to discuss the business challenges and costs of doing business in Egypt for U.S. healthcare companies, including pharmaceuticals and medical device manufacturers. Principals of 15 U.S. companies in Egypt discussed opportunities for collaboration between U.S. businesses and the Egyptian government to help transform the healthcare system into one that meets the needs of industry and the Egyptian public. There was an outstanding confluence of ideas, energy and thought-leadership on the challenges and opportunities in healthcare. As a follow-up, CS Egypt will organize a meeting for the group with the Egyptian Minister of Health.

## Safety and Security Trade Mission to Egypt

From March 21-23, Commercial Service Egypt hosted the Safety and Security Trade Mission to Egypt. Thirteen representatives from nine companies (Brooks Equipment Company Inc., Comtech Mobile Datacom, Field Forensics Inc., Iridian Technologies Inc., L-3 Communications Corporation, Northrop Grumman Mission Systems, Paratus Ltd., SafeView Inc., and Rapiscan Systems) attended more than 90 matchmaking appointments with Egyptian counterparts. CS Cairo Trade Specialists escorted participants to a tour of one of Egypt's most advanced ports, the Soukhna Port, to view current port security and learn about Egyptian port security needs. The mission was highly successful, with one representative agreement already signed, and several under negotiation, in addition to a number of equipment sales.
