

- Sept 1999: FCC staff provides technical documentation regarding agency administration and procedures to **South African** regulators.
- Aug. 1999: FCC Workshop in Johannesburg for South African Telecommunications Regulatory Agency (SATRA) on universal service; pro-competitive regulation; ethics and regulatory transparency.

LATIN AMERICA AND THE CARIBBEAN

- November 2000: Chairman Kennard attends the ITU Development Regulator's Symposium, Geneva and holds bilateral meetings with senior regulators from Peru.
- November 2000: FCC and Argentine officials coordinate at Lima meeting of the Inter-American Telecommunications Commission to promote hemispheric discussion on role of cost models in universal service funding regimes.
- S June 2000: During bilateral discussions in Washington, D.C., Chairman Kennard and Argentina's Communications Secretary, Henoch Aguiar, discuss use of the FCC's HCPM cost model in Aguiar's reform program.
- April-June 2000: FCC experts conduct in-depth discussion of interconnection issues in a series of face-to-face meetings and tele- and videoconferences with officials from Peru's OSIPTEL seeking to develop a new interconnection policy. In June 2000, OSIPTEL

publicly proposes to decrease in the interconnection rate from 3.4 cents/minute to 1.67 cents/minute as the first step to bring interconnection rates down to less than a penny per minute over an 18-month period.

- May 23, 2000: FCC staff provide detailed written explanation of various aspects of the U.S. licensing regime relevant to Argentina's efforts to reform its licensing procedures. Argentina subsequently develops a streamlined licensing regime featuring a single license good for provision of all types of service.
- May 2000 FCC hosts Jamaica Office of Utilities Regulation's (OUR) Deputy Director General Telecommunications, the Director of Analysis and Research, and Senior Economist for in-depth assistance on numbering issues, including economic and cost principles, number administration in the USA and Canada, resource allocation and portability. Jamaica subsequently sought, and now holds a seat on the North American Numbering Council.
- (\$) May 2000: Teleconference between FCC and **Argentine** universal service experts.



- April 2000: FCC experts conduct day-long licensing seminar in Buenos Aires for Argentine Communications Secretary Aguiar and senior staff from the Secretariat of Communications and the National Communications Commission (CNC).
- April 2000: Expert consultations via teleconference between FCC and Peru OSIPTEL staff on international settlement policy.



- March 23-25, 2001, FCC staff members participate with regulators from Brazil, Jamaica and Peru in informal experts talks on PCS spectrum allocation, interconnection and rate rebalancing at the first International Workshop on Communications Regulation. The Los Angeles, CA event was sponsored by the Institute on Global Conflict and Communications (University of California San Diego), the Annenberg Center for Communications (University of Southern California) and the Berkeley Roundtable on the International Economy (University of California, Berkeley).
- Source 2000: Chairman Kennard attends Latin American Telecommunications Summit in Lima, Peru sponsored by the Department of Commerce, the Telecommunications Industry Association and the Peruvian government and participates in a panel discussion with regional regulators on interconnection policy.
- S March 2000: In Buenos Aires, **Argentina**, Chairman Kennard discusses regulatory changes required for full competition with Communications Secretary Aguiar.
- March 2000: Chairman Kennard conducts regulatory seminar for 50 staff members of **Peru**'s regulatory body, the Supervisory Organ for Private Investment in Telecommunications (OSPITEL).
- February 2000: FCC host officials from Jamaica's Office of Utilities Regulation for discussion of interconnection, price caps, and numbering issues.

- February 2000: FCC staff experts provide technical comments on **Jamaican** government's draft telecommunications law designed to create a transition to competition.
- November-December 1999: FCC engineers conduct spectrum occupancy study of the 800, 900 & 2 GHz frequencies for the Government of Jamaica in advance of auctions for 2 new cellular licenses representing the first competition in telephony in the country's history.

ASIA

January 11-13, 2001, FCC staff members participate with regulators from Hungary, Thailand and the Philippines in informal experts talks on universal service and regulatory practice at the second International Workshop on Communications Regulation. The Los Angeles, CA event was sponsored by the Institute on Global

Conflict and Communications (University of California San Diego) and the Annenberg Center for Communications (University of Southern California).

- Nov 2000: Bilateral meetings between Chairman Kennard and Chairman Verma of India's regulatory body (TRAI) during the ITU Development Symposium for Regulators, Geneva.
- Nov 2000: FCC hosts bilateral discussions with Chairman and staff of India's TRAI on future work plan implementation and telecom issues relevant to introduction of competition.
