### Vision Statement

San Juan Island National Historical Park will protect and interpret the historic features of American Camp and English Camp that commemorate the peaceful arbitration of the boundary conflict between Great Britain and the United States known as the Pig War and will protect and restore the cultural landscape that served as the dramatic setting for the events of the joint military occupation of the island, including rare examples of native prairie and Garry oak woodland and the marine environment. San Juan Island National Historical Park will provide visitor facilities that promote compatible recreation and education opportunites that are accessible to a diverse public and which encourage sustainability of resources. This will be achieved through partnerships that emphasize the community of conservation organizations working together to enhance the unique character and quality of life in Puget Sound, the San Juan Islands and the Gulf Islands of Canada.
