Description:

Abstract: This data represents the lands administered by the Bureau of Land Management (BLM) in Nevada that have been identified as suitable to be considered for disposal. Lands for the BLM Ely Field Office (Lincoln, White Pine, and a portion of Nye Counties) have not yet been included in this data. The data indicates where potential lands have been identified but they may no longer be available. This data is intended to be used in conjunction with the BLM Nevada Land Status data layer.

Purpose: This disposal and exchange data layer is intended to be used in support of Land Use Planning, and in the creation of reference maps for public distribution. The data will also be used as an historical reference showing lands administered by BLM Nevada that have been identified under a designating authority as suitable to be considered for disposal. This represents the location of public lands identified for exchange or disposal and is intended to be used for reference only, and not for determination of land ownership.

Supplemental_Information: Public lands identified as suitable for disposal include lands in which the surface is Federally-owned, and may or may not include split-estate lands in which there are reserved Federal interests, depending on how lands were identified as suitable for disposal by the designating authority. Reserved Federal interests in split-estate lands are not identified in other data layers, and must be determined from the master title plats, historical indices, LR2000, and case files. The disposal and exchange data layer may be updated without notice as new lands are identified or removed from consideration for disposal under new designating authorities.

This data was initially compiled by each BLM Nevada Field Office. Some of the field office data layers were very specific and detailed while others were more generalized. Data for the Nevada portions of the Eagle Lake and Surprise Field Offices, administered by BLM California, were not available for this initial version.

The attributes for each data layer were put into a standardized format, as required by NV IM 2004-074, which includes information about the designating authority and FLTFA eligibility. Once the individual field office data sets were standardized they were all merged into a statewide data layer.

The intent for this data is to show where lands have been identified as suitable for disposal and not necessarily where lands are still available. The data is intended to be used in conjunction with the BLM Nevada Land Status data layer, symbolized with the standard agency colors, and is not intended to be used as an indication of land ownership.

Data for the Nevada portion of the Surprise, CA Field Office was received in the form of a FAXed copy of the "Surprise Resource Area MFP III Amendment - Land Tenure" Record of Decision (ROD), and copies of detailed map excerpts indicating the lands identified as suitable for disposal. An updated legal description was also recieved from the Battle Mountain Nevada Field Office for T2NR45E - just East of Tonopah, which was also included in this revision.

The information on the detailed maps and the legal description for T2NR45E were used to identify the corresponding coincident lands from the Geographic Coordinate Database (GCDB) data by township. The coincident lands data for each township was exported, the unnecessary attributes fields were deleted, and the shapefiles were merged into a single data layer. The area, perimeter and acres were updated and verified. Then the standard attribute fields were added, as required by NV-IM-2004-074, and populated with as much information as was available in the Surprise, CA ROD provided. The resulting data was checked for accuracy by GIS staff and forwarded to the FLTFA coordinator to be re-checked. One polygon, representing one sixteenth of one section was identified as missing and was added to complete the update.
