II. Review and Adoption of Meeting Agenda:

CDR Duganne moved to adopt the agenda and CDR Shapiro seconded. Agenda Approved.

III. Review of Previous TPAC Minutes:

December 2008 meeting minutes were provided and approved via e-mail to all TPAC members. Minutes are posted on TPAC website.

IV. CPO Report- CAPT Siegel

- Currently awaiting new nominee from President Obama for Secretary of HHS.
- ASG Galson has been appointed as the AASH. This is beneficial since OCCFM is under the ASH and OCCO is under SG. Having the ASG/AASH filled by ADM Galson provides more unity for operations.
- RADM Furman has been reassigned from Director of OCCO to the position of Senior Advisor to the ASH, where he will serve as Deputy Health attaché in Iraq. CAPT Stevens is now Acting Director of both OCCO and Transformation since RADM Shekar announced his retirement effective 1 March.
- Readiness:
 - As of 31 December the entire Corps was 92.6% Basic Qualified and our Category was 97.87% qualified, the highest of all categories. Only 3 officers in our category were not qualified, and of those 2/3 were only missing one item. Thanks to Readiness for mentoring all officers. Next Readiness check is 31 March.
 - ➤ 256 Commissioned Corps officers deployed to the Inauguration. 750 patients required medical attention and 607 treated by the Corps.

- Coldest inauguration held outside, so most visits were secondary to cold related issues.
- Ship based missions. Announcements have gone out on LISTSERV. Therapists are being identified as a category that can participate. Therapists can participate as health educators for these missions.
- ➤ OFRD Three-Tiered system has been in place for 3 years, so time to rotate team members. First step is to rotate team leadership. If you are interested in participating at Tier 1 or 2, remember supervisor approval is required.
- ➤ Tier 2 teams will now include a patient advocacy team. This team will cover patient education, clinical care coordination, and psycho-social assistance. Therapists roles on this team to be determined.
- Transformation: Billets (complete for our category), Officer Profile (data base for additional degrees, certifications, etc), and Direct Access are current priorities.
- Promotion Benchmarks for 2010 are completed and will be posted on CCMIS website. Expect to see more changes than in years past.
- Promotion Boards for 2009 are starting to meet and will continue to meet until May. Check eOPF and make sure all items included.2
- Effective February 2009, DCCA launched a revised overall CAM team structure with leadership for four (4) teams, instead of the current six (6) team structure. Therapist category falls under the Blue Team:
 - Blue Career and Assignment Manager Team: Health Services, Medical, Environmental Health, Engineer, Veterinary, and Therapist categories.
 - CDR Laurie Kelley Career and Assignment Manager Blue Team Coordinator
 - CDR McMillan is no longer working with Therapist, as he is on the Gold Team.
- CAPT Siegel attended APTA Combined Sections Meeting in Las Vegas February 9-12 and was able to meet with many Category Officers.
- AOTA is holding it's annual conference at the end of April in Houston.
 CAPT Siegel needs PHS representation at a meeting there, so if any OTs are planning to attend, please notify her.

B. News From the Field:

BOP East

FMC Butner, Butner, NC

Special thanks to the following therapists who volunteered their expertise during the Inmate Diabetic Health Fair on Saturday November 8, 2008 at Butner, NC. This event impacted over 800 inmates who received information regarding diabetes control, exercise prescriptions, improving diet, and improving foot care. LT Gwen Hall, PT, LT TaNesha Nobles, PT, LT Alice Priest, PT, LT Stan Bennett, PT and LTJG Darren Hearn, PT all participated.

LCDR Damien Avery, PT has been serving as an Orthopedic Specialist (O-5 Billet) within the Butner Orthopedic Clinic and has done a superior job at integrating the Rehabilitation Services Department with the Orthopedic Clinic. Additionally LCDR Avery is being trained to provide support and assistance to the orthopedic surgeon during surgeries and Damien is really enjoying his OR time.

LCDR Douglas Henry, PT is starting his transition to that of Wound Care Specialist (O-5 Billet) at FMC Butner. He has provided outstanding consultation services for our more complex chronic wound patients. By mid- April 2009 LCDR Henry will be serving in this capacity full time due to the increased prevalence of chronic wounds amongst our more ill patient population.

FMC Lexington, Lexington, KY

The Therapy Department at Lexington, KY is in the process of establishing a sanctioned Inmate Aide Program to assist other inmates who are not fully independent.

Starting in January an EMG program was initiated by LT Alex Brenner, PT who is currently credentialed to perform EMG studies. As of 6 Feb, LT Brenner has completed 13 EMG's resulting in substantial cost savings to the facility by not having to send these patients to the medical centers for these diagnostic tests.

CDR Fred Lief, PT and LT Alex Brenner, PT submitted a proposal to Lexington Warden Stephen Dewalt regarding the revamping of our wheelchair program. The proposal was well received and resulted in moving the wheelchair shop to a new and larger location within the facility. We will be implementing a new wheelchair preventive maintenance program with aims to prolong the life of the current wheelchairs by replacing the commonly worn out parts rather than replacing entire wheelchairs. This proposal should result in substantial cost savings to the Bureau.

A portion of the Chinle Service Unit COs will be receiving additional FEMA training (modules 300 & 400) on-site in Chinle (course 300 is 2/17-18/09 for two 12 hr training days). The goal is to have the COs run/manage the Hospital Incident Command System (HICS) by mid-summer.

Subject: Retention Subcommittee February 2009 Report

The Retention SubCommittee has finalized the most recent cycle of evaluating issues affecting retention of Therapist Category officers. This process has consisted of generating a comprehensive survey of current issues influencing retention, a summary report of survey findings, and in-depth review of specific survey topics. The final product of this effort is an information guide to enhance the knowledge and understanding of benefits and resources available to Officers.

In reviewing the survey findings, the initial focus of the Subcommittee was on compensation of Therapist Category officers. A detailed review of officer's

compensation was completed confirming therapists' responses of equity with the civilian market. On average, compensation for PHS Therapist Officers appears to be consistent with the civilian marketplace. One area of that appears to marginally insufficient is compensation for new graduates without prior military service. These officers may have initial compensation that is lower than civilian counterparts; the difference in compensation is affected by varying levels of the Basic Allowance for Housing (BAH). Additionally, most new hires in the civilian marketplace are offered an initial sign-on bonus when accepting employment. This factor also affects practicing therapists who are considering entry into the Commissioned Corps. Currently, there is no organization that monitors and quantifies signing bonuses in the therapy industry making it extremely difficult to address this disparity.

The Retention SubCommittee also placed emphasis on identifying financial retention incentives for Therapist Officers. Currently, Assignment Incentive Pay (AIP) is the only is only retention incentive available to Therapist Category Officers. Assignment Incentive Pay (AIP) is a recently established incentive that therapist officers are eligible for based on assignment designation and agency approval. Assignment Incentive Pay is for designated Critical Public Health Assignments (CPHA) which include Iso/Hard Assignments, Hazardous Duty, Medical and Dental Assignments, and any Assignment designated by the authorizing agency as "Critical Need". At this time, AIP is authorized for all Corps Officers that meet the above criteria and that the Agencies have determined to be eligible in regards to mission needs.

The SubCommittee also researched and reported on a variety of other topics from the survey. The information from this survey review has been consolidated into a final summary report. The report addresses specific questions from the retention survey and provides information and/or resources to address the topic. This final report will be posted on the TPAC website and available for officers to review.

As mentioned on the TPAC call in February, Thera-Chat is not an official TPAC- or USPHS-sanctioned website, but it may benefit officers as a resource for unofficial therapy-related discussions and networking.

Thera-Chat Oversight

The PHSChat site moderator maintains a standard level of oversight and provides general participation guidelines for the website. Thera-Chat will be furthered moderated by LT Carlos Estevez, he will screen the therapist area for appropriate use and content and monitor trends and topics. LT Estevez will provide this oversight for a period of two months, after which he will provide a written report to the TPAC Chair on how the site has been used and if any significant trends have emerged.

Thera-Chat Access

The PHSChat website is found at http://www.phschat.com. New users will need to register and create an identity to use the site. The site is "casual" in its format, so it is requested that officers operate on a first-name (or username) basis without including rank. Click "Register" on the top left of the screen and it will walk you through the process.

Thera-Chat (therapy category section) is password protected to prevent viewing by the general public and other website users. To locate the Thera-Chat area:

- Click "Categories" heading on the left
- Click "Professional Category Forums."
- Click "Therapist."
- Click "Forum Jump" On the bottom right corner of the screen there will be a small bar

 Click the down arrow (not the "go" button) to open a list of Thera-Chat discussion categories. The categories were created to help group similar topics.

Current discussion categories are as follows, including some suggestions for potential topics:

- 1. Clinical Discussion (e.g. case studies, evidence-based practice notes, recommended articles or article reviews)
- 2. Administrative (e.g. scheduling and management idea-sharing, hints on report development and/or presentation)
- 3. Agency-Related Discussion (e.g. mentoring discussions, what is it like to work for a specific agency or in a certain role?)
- 4. General Announcements (e.g. social events, etc.)
- 5. Educational Opportunities

The site does allow the flexibility to modify the discussion categories and groupings over time to best fit our needs.

User responsibility

The Thera-Chat site is in the public domain and is in no way sanctioned by the USPHS, Commissioned Officers Association or Therapist Professional Advisory Committee. As such, utilization of the site is not a requirement, but would be voluntary similar to any other discussion or forum website. Since it is in the public domain, however, it is important for officers to remember to maintain professionalism at all times. Officers should always be aware of how their posting might reflect on the Corps, the Therapist Category and/or themselves.

Used in a professional and conscientious manner, the Thera-Chat website has the potential to be a beneficial resource to therapist officers. Officers are encouraged to explore the website and take part in the discussions and information sharing.
