### **Idaho**

The following is a profile of Idaho and includes information on demographics, political figures, programs, crime statistics, drug use, drug trafficking and enforcement.

#### **Demographics**

#### **Programs/Initiatives**

- ➤ Idaho Drug Free Youth (IDFY)<sup>10</sup>
  - IDFY is a statewide program developed to help middle and high school students resist tobacco, drug and alcohol use. Joining students sign a pledge promising to be drug free and submit to random drug testing.
- ➤ Idaho Drug Endangered Children (DEC) Program<sup>11</sup>
  - The Idaho DEC serves to coordinate and document the work of a multi-disciplinary team comprised of law enforcement, emergency room physicians, emergency medical services, fire departments and Children and Family Services to respond effectively to illicit drug laboratories and other drug environments where children are present and declared in imminent danger.
- ➤ Idaho Meth Project<sup>12</sup>
  - By using consumer marketing and advertising strategies as the basis for its outreach, the goal of the Idaho Meth Project is to significantly reduce the prevalence of firsttime methamphetamine use in Idaho.

#### **Crime and Drug-Related Crime**

➤ During 2007, the Drug Enforcement Administration (DEA) reported making 143 arrests for drug violations in Idaho.<sup>13</sup>

➤ During 2006, there were 5,063 adult and 834 juvenile drug/narcotics violation arrests in Idaho. 14

#### **Drugs**

> Cocaine 16

Cocaine is becoming more popular in Idaho, although crack cocaine is not considered a significant threat.

➤ Heroin<sup>17</sup>

Mexican black tar is the predominate form of heroin available in Idaho, with brown heroin encountered sporadically.

➤ Marijuana<sup>18</sup>

Marijuana is one of the most highly abused drugs in Idaho.

- ➤ Methamphetamine<sup>19</sup>
  - Crystal Methamphetamine (ice) is a widely abused drug in Idaho, and continues to impact all elements of society. Idaho has experienced a dramatic decrease in methamphetamine labs as Mexican organizations turn to methamphetamine produced in Mexico.
- ➤ Club Drugs<sup>20</sup>

- Club drugs, particularly MDMA, continue to be popular among young adults in the state. These drugs are most often found at rave venues.
- ➤ Pharmaceutical Diversion<sup>21</sup>
  The abuse and trafficking of oxycodone (OxyContin, Percocet and Percodan), hydrocodone (Vicodin and Lortab), methadone and anabolic steroids continues to be
- According to 2005-2006 data from the National Survey on Drug Use and Health (NSDUH), approximately 84,000 (7%) of Idaho citizens (ages 12 or older) reported past month use of an illicit drug.<sup>22</sup>

- Additional 2005-2006 NSDUH results indicate that 35,000 (3.00%) Idaho citizens reported illicit drug dependence or abuse within the past year. Approximately 22,000 (1.87%) reported past year illicit drug dependence.<sup>23</sup>
- Approximately 443,000 (37.85%) Idaho citizens reported that using marijuana occasionally (once a month) was a "great risk," according to 2005-2006 NSDUH data.<sup>24</sup>
- According to 2007 data from a survey of Idaho 12-24 year olds, 87% of respondents reported that regular methamphetamine use was a "great risk," 85% reported regular heroin use was a "great risk" and 84% reported regular cocaine use was a "great risk". 25

#### Juveniles

Approximately one-third (33.1%) of Idaho high school students surveyed in 2007 reported using marijuana at least once in their lifetime. <sup>26</sup>

#### **Enforcement**

➤ As of October 31, 2006, there were 3,896 full-time law enforcement employees in Idaho (2,594 officers and 1,302 civilians). <sup>29</sup>

#### **Trafficking and Seizures**

Mexican drug trafficking organizations involved in the trafficking of methamphetamine, marijuana and cocaine are the greatest threat to the state.<sup>30</sup>

- ➤ The northern portion of the Idaho panhandle shares a border with Canada and this area has been the subject of seizures of BC Bud marijuana being smuggled from Canada to the United States.<sup>31</sup>
- ➤ During 2007, the DEA and state and local authorities in Idaho reported 11 methamphetamine lab incidents. <sup>32</sup>

➤ Approximately 1,323.5 kilograms of marijuana were seized by Federal agencies in Idaho during 2007.<sup>33</sup>

➤ During 2007, more than 36,000 cultivated marijuana plants were eradicated in Idaho under the DEA's Domestic Cannabis Eradication/Suppression Program. <sup>34</sup>

➤ During 2006, law enforcement agencies in Idaho seized 42.5 pounds, 10.1 gallons and 285 dosage units of amphetamines/methamphetamine.<sup>35</sup>

#### Courts

- ➤ Drug Courts<sup>36</sup>
  - As of April 16, 2007, there were 42 drug courts in existence or being planned in Idaho. Thirty-five drug courts had been operating for at least two years, 1 had recently been implemented and 6 were being planned at that time.
- ➤ During FY 2007, approximately 28% of the Federally-sentenced defendants in Idaho had committed drug offenses. More than 70% of the drug cases involved methamphetamine.<sup>37</sup>

#### **Corrections**

- ➤ As of December 2007, there were 7,355 incarcerated offenders within the Idaho Department of Corrections (IDOC). <sup>38</sup>
- ➤ There were 12,959 IDOC offenders being supervised in the community as of December 2007 (10,567 on probation and 2,392 on parole).<sup>39</sup>
- As of December 2007, approximately 25% of the prisoners and 36% of those under community supervision had drug offenses as their most serious type of crime. 40

- Therapeutic community (TC) treatment programs are offered at 4 IDOC facilities: Idaho Correctional Institution Orofino (ICIO), South Idaho Correctional Institution (SICI), Pocatello Women's Correctional Center (PWCC) and Idaho Correctional Center (ICC).<sup>41</sup>
- > During FY 2007, more than 676 offenders participated in TC programs at IDOC facilities. Seventy percent of TC participants completed the programs. 42

#### **Consequences of Use**

> During 2007, authorities reported that there were 4 children affected by methamphetamine laboratories in Idaho.<sup>43</sup>

#### **Treatment**

> During 2007, more than 7,500 clients received outpatient substance abuse treatment services in Idaho.44
