Programs/Initiatives

- High Intensity Drug Trafficking Area (HIDTA)¹⁰
Designated in 1996, the Gulf Coast HIDTA is responsible for Baldwin, Jefferson, Madison, Mobile, Montgomery and Morgan counties in Alabama. In addition to Alabama, the Gulf Coast HIDTA is also responsible for counties in Louisiana and Mississippi.
- Division of Substance Abuse Services¹¹
The Division of Substance Abuse Services has the responsibility for the development, coordination and management of a comprehensive system of treatment and prevention services for alcoholism/drug addiction and abuse within Alabama.

Crime and Drug-Related Crime

- During 2006, the Drug Enforcement Administration (DEA) reported making 137 arrests for drug violations in Alabama.¹²

- During 2006, there were 14,816 adult arrests for drug possession in Alabama.¹³ This is down slightly from 2005, when there were 14,990 adult arrests for drug possession.¹⁴

- There were 1,118 juvenile arrests for drug possession in Alabama during 2006.¹⁵ In 2005, there were 1,160 juvenile arrests for drug possession in Alabama.¹⁶

- There were 374 homicide arrests in Alabama during 2006. Twenty of these arrests involved individuals under the age of 18.¹⁷

Drugs

- Cocaine¹⁸

Law Enforcement agencies throughout Alabama report that cocaine is a significant drug threat and is widely available throughout the state.

- Heroin¹⁹
Law enforcement intelligence indicates that over the past year the presence of heroin in Alabama has increased. This intelligence has been substantiated by the increase in the number of patients admitted to clinics for treatment.
- Marijuana²⁰
Marijuana is the most widely abused and available drug in Alabama.
- Methamphetamine
Methamphetamine has been identified by law enforcement as the primary drug threat in Alabama. The methamphetamine previously produced in “mom and pop” labs in Alabama has been replaced by a more pure form of the drug known as “ice.”
- Club Drugs²¹
Club drug abuse and distribution among young people is on the rise in Alabama. Increases in arrests, overdoses and seizures of designer drugs have been reported and indicate a trend toward increased availability and trafficking. MDMA, LSD, GHB and Ketamine are readily available throughout the state and are most commonly found on college campuses. GHB and MDMA have emerged as club drugs of choice within the state.
- Other Drugs²²
Hydrocodone was the most abused pharmaceutical drug in 2005. Other drugs commonly diverted and abused were OxyContin and Vicodin.
- According to 2004-2005 data from the National Survey on Drug Use and Health (NSDUH), approximately 275,000 (7%) of Alabama citizens (ages 12 or older) reported past month use of an illicit drug.²³

- Approximately 1.9 million (49.93%) Alabama citizens reported that using marijuana occasionally (once a month) was a “great risk”.²⁴
- Additional 2004-2005 NSDUH results indicate that 113,000 (3%) Alabama citizens reported illicit drug dependence or abuse within the past year. Approximately 74,000 (1.98%) reported past year illicit drug dependence.²⁵

Juveniles

- Approximately one-third (33.3%) of Alabama high school students surveyed in 2005 reported trying marijuana at least once in their lifetime.²⁶

- Approximately 10% of Alabama 12th graders surveyed in 2005 reported using cocaine at least once during their lifetime.²⁷

Enforcement

- As of October 2006, there were 16,256 full-time law enforcement employees in Alabama (10,719 officers and 5,537 civilians).²⁹

Trafficking and Seizures

- Mexican, Caribbean and regional drug trafficking organizations have extensive distribution networks within Alabama.³⁰
- Cocaine is transported into Alabama primarily from the Houston, Texas or Atlanta, Georgia areas. Wholesale distributors transport cocaine into the state in its powder form, a majority of which is then converted locally into crack.³¹
- Virtually all of the methamphetamine coming into the state is brought in by Mexican drug trafficking organizations from Mexico and Texas and distribution points in Atlanta, Georgia.³²
- Mexican drug trafficking organizations are responsible for the majority of bulk marijuana transported into the state. Local independent dealers and African American drug trafficking organizations distribute marijuana in the local retail market.³³
- The number of reported methamphetamine laboratory incidents by the DEA and state and local authorities in Alabama has decreased from 276 in 2005 to 193 in 2006.³⁴

- Approximately 1,911.4 kilograms of marijuana were seized by Federal agencies in Alabama during 2006.³⁵

- During 2006, 48,177 cultivated marijuana plants were eradicated in Alabama under the DEA's Domestic Cannabis Eradication/Suppression Program.³⁶

Courts

- Drug Courts³⁷
As of April 16, 2007, there were 29 drug courts in Alabama that had been operating for at least two years, 2 that had recently been implemented and 5 that were being planned.
- During FY 2006, approximately 35% of the Federally sentenced defendants in Alabama committed drug offenses. Nearly one-third (32.3%) of these Federal drug cases involved methamphetamine.³⁸

Corrections

- As of September 2007, the Alabama Department of Corrections (DOC) population was 29,235. Approximately 18% of the total population was in custody for committing drug crimes.³⁹

- As of December 31, 2005, there were 38,995 adults on probation and 7,252 adults on parole in Alabama.⁴⁰

Consequences of Use

- According to the El Paso Intelligence Center, there were 36 children in Alabama affected by methamphetamine laboratories during 2005.⁴¹

Treatment

- During 2006, there were 20,840 admissions to drug/alcohol treatment in Alabama.⁴² There were 20,081 treatment admissions in 2005.⁴³ During 2004, there were 19,838 admissions to treatment in Alabama.⁴⁴

- According to 2004-2005 NSDUH data, approximately 92,000 (2.47%) Alabama citizens reported needing but not receiving treatment for illicit drug use within the past year.⁴⁵
