2006 Alternative Dispute Resolution Awards in Acquisition

I am pleased to announce the fifth annual competition to recognize outstanding examples of alternative dispute resolution (ADR) by federal agencies and private sector organizations in acquisition matters. The Office of Federal Procurement Policy (OFPP) established the awards in 2002 as a result of a suggestion from the Contracts and Procurement Section of the Interagency ADR Working Group. The awards program is co-sponsored by OFPP and the Chief Acquisition Officers Council. Last year's winner was the Department of the Navy, Naval Facilities Engineering Command.

The competition recognizes agencies and private sector organizations that use a variety of consensual techniques to resolve federal acquisition disputes. Appropriate use of voluntary ADR resolves disputes in a manner that is more efficient and timely than traditional litigation processes, while preserving the business relationships between agencies and their private sector partners.

The attached materials provide complete information on award eligibility and selection criteria. This year, we are asking for nominations that recognize a specific ADR initiative that was particularly noteworthy. If your organization was involved with a particularly significant or innovative use of procurement-related ADR, please submit a nomination. I would appreciate your sharing this announcement with interested agency personnel, including your program managers, office of general counsel, dispute resolution specialists, and any interested private sector organizations.

## **ADR AWARD NOMINATION REQUIREMENTS**

### **Purpose**

Traditional dispute resolution through formal administrative procedures and court litigation often imposes a “solution” handed down by a third party, typically after significant expenditures of time and resources. By contrast, alternative dispute resolution (ADR) is often significantly less costly and time consuming, and can provide long-term solutions to conflicts between federal agencies and private sector contractors, while helping to preserve working relationships.

ADR is designed to satisfy an organization’s needs and should be administered in such a way as to optimize the possibility of amicable resolution of disputes. ADR awareness and skills training is essential to the effective use of ADR. Successful ADR initiatives achieve significant positive results in terms of fair and expeditious dispute resolution, and include appropriate means of measuring, evaluating, and institutionalizing ADR best practices.

The OFPP awards for outstanding acquisition ADR initiatives are intended to:

- Recognize federal and private sector organizations that are innovatively and effectively utilizing ADR to resolve disputes relating to federal acquisitions and contracts;
- Encourage the establishment and improvement of highly effective, voluntary ADR mechanisms throughout the Government and similar initiatives in private industry; and
- Publicize exemplary acquisition-related ADR initiatives and “best ADR practices.”

### **Nomination Eligibility**

- Any department, agency, private sector entity, or component thereof, may nominate itself for this award.
- Nominations may describe ADR-related activities and initiatives undertaken by an entire agency or private sector organization, or activities, or initiatives undertaken by their respective subdivisions, facilities, or offices.
- An award may recognize a particularly significant ADR effort or achievement, even if focused on an individual matter, or a single project or acquisition program.

### **Selection Criteria**

OFPP encourages organizations to focus the discussion supporting their nominations on elements that have contributed to fair and efficient resolution of acquisition-related disputes, organizational effectiveness, and fostering of positive relationships between federal agencies and their private sector partners.

## **CRITERIA FOR ADR INITIATIVE NOMINATIONS**

### **CRITERION #1 –Innovation**

- How and why was the initiative conceived?
- What type of ADR was used?
- What creative or innovative techniques were employed?

### **CRITERION #2 – Significance**

- What was the significance of the ADR effort to the Agency and to the private sector participant?
- How did the ADR effort contribute to the overall goals and objectives of the Agency and the private sector participant?

### **CRITERION #3 – Relationship Building**

- How did the ADR effort foster the working relationship of the parties and contribute to a mutually beneficial outcome?

### **CRITERION #4 – Training/Preparation**

- What training or other steps were taken to institutionalize the ADR best practices used for this initiative?

### **Submission of Nominations**

**Nomination program descriptions should be no more than 5 pages.** Due to mail delays at the White House complex, please do not mail nomination materials to OFPP. Please electronically submit your nominations, including the attached form, to [jwise@omb.eop.gov](mailto:jwise@omb.eop.gov) no later than March 30, 2007.

### **Selection of Award Winners**

OFPP selected a distinguished panel of judges for this year's competition. The judges include: the Honorable William Webster, Partner, Milbank, Tweed, Hadley, and McCloy; Anthony N. Palladino, Chair, Interagency ADR Working Group, Contracts and Procurement Section and Director, FAA Office of Dispute Resolution for Acquisition; and Lynda Troutman O'Sullivan, Assistant Deputy General Counsel for Dispute Resolution, United States Air Force. The judges will review the nominations and make recommendations to OFPP. OFPP will make the final award decision. The award winner will be recognized by OFPP in a ceremony at the White House to be held in May 2007.
