

Data collected from New Orleans adult arrestees in 2003 indicate that 78.4% of adult male and 59.8% of adult female arrestees tested positive for one of the following drugs at arrest: cocaine, heroin, marijuana, methamphetamine, or PCP.²⁰

Over 60% of adult male arrestees reported using marijuana in the past year. Among the male arrestees who reported past year use of marijuana, the average number of days the substance was used in the past month was 11.0 days.²¹

Drugs

Cocaine/Crack

The abuse of cocaine, especially crack cocaine, continues to be a major drug problem in New Orleans. In 2002, powder cocaine sold for \$80-\$150/gram, \$800-\$1,200/ounce, and \$20,000/kilogram. Crack cocaine sold for \$8,000/ounce, \$15/rock, and \$20,000-\$28,000/kilogram.²⁴

➤ Heroin

Heroin is becoming more available and more affordable in the New Orleans area.²⁵ It has become an easily obtainable substitute to OxyContin.²⁶ Despite the increase in heroin snorting, injection remains the predominant route of administration. Some younger users are lacing marijuana cigarettes with heroin.²⁷ In 2002, heroin purity in New Orleans was 36.18% and heroin sold for \$300-\$600/gram, \$4,000-\$9,000/ounce, and \$80,000-\$100,000/kilogram.²⁸

Marijuana

Marijuana continues to be the drug of choice among young people in New Orleans.²⁹ Locally produced commercial grade marijuana is the most common variety found in New Orleans, followed by Mexican commercial grade marijuana. Marijuana is predominantly smoked in joints, but blunts are occasionally reported, mostly among people visiting the city.³⁰ In 2002, marijuana sold for \$2/joint, \$100/gram, \$125-\$160/ounce, \$750-\$1,000/pound, and \$2,000/kilogram in New Orleans.³¹

> Methamphetamine

According to *Pulse Check* treatment sources, the number of novice methamphetamine users (those who have used methamphetamine for less than one year before entering treatment) has increased in New Orleans.³² In 2002, methamphetamine sold for \$100-\$150/gram, \$900-\$1,500/ounce, and \$12,000-\$16,000/pound in New Orleans.³³

Club Drugs

The use of club drugs is reported in clubs and bars in the French Quarter area of the city.³⁴ The average price of an MDMA tablet in New Orleans was \$15.25 in 2001. GHB and GBL prices were \$5/capsule or \$10/ounce.³⁵

Diverted Pharmaceuticals

OxyContin has replaced hydromorphone as the most popular opiate of abuse in the New Orleans area.³⁶ OxyContin pills usually cost \$100 per 40 milligrams. The most frequently mentioned OxyContin diversion method in New Orleans is forging prescriptions. Some patients also fill legal and legitimate prescriptions and sell some of the pills. OxyContin injection remains a popular form of administration in New Orleans.³⁷

Juveniles

Among New Orleans high school students surveyed in 2003, approximately 29.5% of female students and 40% of male students reported using marijuana at least once during their lifetime.³⁸

Enforcement

As of October 31, 2002, there were 2,000 full time law enforcement employees in New Orleans (1,613 officers and 387 civilians).⁴³

Trafficking and Seizures

- Most of the cocaine trafficking in the New Orleans area is handled by Colombia- and Mexico-based organizations that operate out of California and Texas.⁴⁴
- The Gulf Coast HIDTA's geographic location between the southwest border and the eastern seaboard serves as a strategic corridor for traffickers transporting drugs and money to and from the eastern and northern parts of the country.⁴⁵
- The area's waterways, deepwater ports, railway and highway systems, and airports are used extensively by drug trafficking and smuggling operations.⁴⁶
- The Port of New Orleans is a transportation hub and distribution center for licit and illicit commodities. It is also a popular embarkation point and destination for the Caribbean cruise ship circuit, providing an opportunity for American and foreign passengers to smuggle drugs.⁴⁷

- Drug trafficking organizations use commercial and charter flights at the New Orleans International Airport to smuggle cocaine and heroin from Central America and Mexico. The New Orleans International Airport is the only airport in the Gulf Coast region that receives international flights from Central America.⁴⁸
- Most of the methamphetamine available in New Orleans originates in Mexico and California and is transported through Texas.⁴⁹
- According to the DEA, approximately 71.75 kilograms of cocaine were seized in New Orleans during the 1st quarter of FY 2003. This is up from 13.05 kilograms seized in the 4th quarter of FY 2002.⁵⁰

Courts

➢ Drug Courts⁵¹

As of May 2004, there were 2 drug courts that had been operating for over 2 years in New Orleans. There were no additional drug courts in existence or being planned.

Corrections

- On July 1, 2002, approximately 11% (11.4%) of the adults on probation in Louisiana were from Orleans Parish. 8.8% of those on parole and 14% of those on good-time parole supervision were also from Orleans Parish.⁵²
- 19.3% of the adults in Louisiana correctional facilities on July 1, 2002 were from Orleans Parish. 28.1% of youthful offenders in the state correctional system were from Orleans Parish. The youthful offender population is made up of inmates who were 14, 15, or 16 at the time of admission and who were convicted in criminal court and sentenced to the custody of the Department of Public Safety and Corrections.⁵³

Consequences of Use

During 2002, there were 4,566 drug-related emergency department (ED) episodes in New Orleans. Cocaine was mentioned 1,674 times in the ED episodes.⁵⁴

- During 2002, the Orleans Parish Coroner's Office reported 269 homicides. This is up from 215 homicides in 2001. Drug-related homicides increased from 50% in 2001 to 80% in 2002.⁵⁵
- During 2002, Orleans Parish medical examiners (ME) reported 82 drug abuse deaths. Cocaine was mentioned in 43 of the deaths.⁵⁶

Approximately 14% of the New Orleans adult male arrestees interviewed during 2003 reported receiving inpatient or residential treatment at some point in their lives.⁵⁷
