
ARRA - Section 402

• Authorizes Western's Administrator to:

Construct Finance Facilitate
Plan Operate Maintain
Study

- New, upgraded transmission
- One terminus in Western's service area
- Facilitate delivery of renewable energy to markets

Western's service territory



Legislative authority & requirements

 Authorized to borrow funds from Treasury

 Use a public process to develop practices and policies to implement authority

Proposed program goals

- New, upgraded transmission
- Help bring renewable energy to market

Proposed Program Objectives:

- Encourage non-Federal participation
- Leverage borrowing authority

Components:

- Project funding
- Project evaluation
- Project development
- Project O&M
- Project rates and repayment

Proposed program principles

Each project:

- Public interest
- System reliability, ops, statutory obligation
- Proceeds adequate for repayment
- Public process for Western rates
- Ancillary services
- Repay principle, interest after
 - Ancillary services
 - Project O&M

Proposed program principles, con't.

Program:

- Provides participation opportunity for others
- Uses project revenues as only source to:
 - Repay associated loan
 - Pay ancillary services, O&M expenses
 - Credit payments to Western power systems for provided ancillary services
- Maintain controls for accounting, repayment to ensure separate, distinct treatment

Comment Process

- Critical to the success of this program
- Most useful if:
 - Specific
 - Offer proposals
 - Include suggested changes or methodologies
 - Provide rationale
 - Refer to section of proposed program
