The following profile contains information on demographics, political figures, programs, crime, drug use, drug trafficking and enforcement.

Demographics

- Population (2006 American Community Survey): 115,575¹
- ➤ Race/Ethnicity (2006 American Community Survey): 51.0% white; 42.0% black/African American; 0.2% American Indian/Alaska Native; 3.6% Asian; 0.1% Native Hawaiian/other Pacific Islander; 1.3% other; 1.8% two or more races; 4.8% Hispanic/Latino origin (of any race)²
- Columbia is located in Lexington and Richland Counties.³

Programs

➤ LRADAC, The Behavioral Health Center of The Midlands⁸
This program offers prevention, intervention and treatment programs to citizens of Lexington and Richland Counties

Crime and Drug-Related Crime

➤ During 2006, the Columbia Police Department reported 7 homicides. This is down from 15 murders reported during 2005. 9

- Lexington County authorities reported 1,805 arrests for drug law violations in 2006. Richland County law enforcement agencies reported 3,042 drug arrests during 2006. 10
- ➤ There were 171 reported drug-related crimes involving at least one gang member reported in Lexington and Richland Counties from January 1, 2006 though April 30,

2007. Law enforcement intelligence indicates considerable gang member involvement in drug activity and crimes in the area. 11

Drugs

➤ Heroin¹²

Mexican drug-trafficking organizations are the most common sources for heroin in the Columbia.

➤ Methamphetamine ¹³

From January through June 2007, methamphetamine prices in Columbia were as follows: \$80-\$120/gram, \$900-\$1,100/ounce and \$12,000-\$15,000/pound. Prices for crystal methamphetamine during that time period were as follows: \$88-\$132/gram, \$1,100-\$1,300/ounce and \$15,000-\$18,000/pound.

Club Drugs¹⁴
 Ecstasy (MDMA) is readily available in Columbia.

Juveniles

Area school resource officers have indicated that children in Lexington and Richland Counties lacked positive activities and turned instead toward drugs and crime. A number of area principals believe that the availability of drugs in some neighborhoods is a problem for their students¹⁵

Enforcement

- As of October 2006, there were 368 full-time law enforcement employees in Columbia (328 officers and 40 civilians). 16
- ➤ Columbia Police Department: Organized Crime and Narcotics Unit (OCN)¹⁷ OCN is responsible for investigating vice, organized crime, illegal drugs and conducting intelligence related to such activities.

Trafficking and Seizures

➤ During the past year, there has been a significant increase in ecstasy distribution throughout South Carolina with traffickers based out of Columbia distributing a significant portion of the Ecstasy sold. ¹⁸

Courts

➤ Drug Courts¹⁹

As of April 16, 2007, there were 2 drug courts in Columbia that had been in existence for at least two years. There were no additional drug courts in existence or being planned in Columbia at that time.

Corrections

On June 30, 2007, approximately 9.1% of the South Carolina Department of Corrections inmate population was from Richland County and 4.2% was from Lexington County.²⁰

Treatment

➤ During FY 2007, there were 3,709 admissions to drug treatment involving Richland and Lexington County residents. ²¹
