#### **Demographics**

- ➤ Population (2005 American Community Survey): 477,251<sup>1</sup>
- ➤ Race/Ethnicity (2005 American Community Survey): 53.6% white; 8.3% black/African American; 1.0% American Indian/Alaska Native; 12.3% Asian; 0.2% Native Hawaiian/other Pacific Islander; 22.1% other race; 2.5% two or more races; 43.9% Hispanic origin²
- ➤ The city of Fresno is located in Fresno County.

#### **Programs/Initiatives**

- ➤ High Intensity Drug Trafficking Area (HIDTA)<sup>8</sup>
  Designated in 1999, the Central Valley HIDTA is responsible for the following counties in California: Fresno, Kern, Kings, Madera, Merced, Sacramento, San Joaquin, Stanislaus, and Tulare.
- Police Activities League (PAL)<sup>9</sup>
  The Fresno Police Department's PAL is a nonprofit organization committed to promoting mentor relationships between youth and law enforcement personnel. Atrisk youth and police officers work together on activities designed to develop discipline, self-esteem, mutual trust and respect.

#### **Crime and Drug-Related Crime**

From January to June 2006, the crime index total for Fresno was 14,236. During full year 2005, there were 29,691 index offenses reported in Fresno. 10

➤ During 2005, the Fresno Police Department's Major Narcotics Unit made 122 arrests and the Fresno Meth Task Force made 41 arrests. <sup>11</sup>

#### **Enforcement**

- > Fresno Meth Task Force 12
  - This task force works to reduce large-scale manufacture and distribution of methamphetamine and precursor chemicals from the HIDTA's area of responsibility.
- Special Operations Task Force<sup>13</sup>
  This task force identifies and removes mid-level drug traffickers who are active in, or connected with, criminal groups and/or street gangs.
- As of October 31, 2004, there were 1,140 full-time law enforcement employees in Fresno (769 officers and 371 civilians). <sup>14</sup>

#### **Trafficking and Seizures**

➤ During 2005, the Fresno Police Department's Major Narcotics Bureau seized 66.1 pounds of methamphetamine valued at \$1,938,200. 15

➤ The Fresno Meth Task Force dismantled 16 clandestine methamphetamine labs during 2005. <sup>16</sup>

➤ The Fresno Special Operations Task Force seized 4 pounds of marijuana and \$200,000 in currency during 2005. 17

#### **Courts**

➤ Drug Courts<sup>18</sup>

As of August 2006, there were 3 drug courts in Fresno that had been operating for more than 2 years. There were no additional drug courts in existence or being planned in Fresno at that time.

#### **Corrections**

- ➤ As of December 31, 2005, approximately 3.1% (5,221 offenders) of the California Department of Corrections inmate population had Fresno County as their county of commitment.<sup>19</sup>
- ➤ The county of commitment for 4.1% (4,681 offenders) of the California parole population on December 31, 2005 was Fresno County. <sup>20</sup>

#### **Treatment**

➤ In FY 2004-2005, there were 2,481 Fresno County treatment admissions in which methamphetamine was the primary substance of abuse. <sup>21</sup>
