Programs/Initiatives

- ➤ High Intensity Drug Trafficking Area (HIDTA)⁹
 Designated in 1990, the Southwest Border HIDTA/Arizona Region is responsible for the following Arizona counties: Cochise, La Paz, Maricopa, Mohave, Pima, Pinal, Santa Cruz and Yuma.
- Arizona Substance Abuse Partnership (ASAP)¹⁰
 ASAP serves as the single statewide council on substance abuse issues. ASAP brings together stakeholders at the Federal, state, tribal and local levels to: improve coordination across state agencies, address identified gaps in prevention, treatment and enforcement efforts and improve fund allocation.
- Governor's Division for Substance Abuse Policy¹¹
 The mission of the Governor's Division for Substance Abuse Policy is to improve and expand substance abuse education, prevention and treatment throughout Arizona.
- ➤ Drug Endangered Children (DEC) Program¹²
 The Arizona DEC was established in 2000 (as the Meth and Kids Task Force) to address the problems associated with meth production in homes where children are present. In 2003, the program was renamed the Drug Endangered Children Program to include a broader range of drug cases involving child endangerment.
- ➤ Parents Commission on Drug Education and Prevention ¹³ Created by the passage of Proposition 200 ("The Drug Medicalization, Prevention and Control Act"), the mission of Arizona's Parents Commission is to fund programs that will increase and enhance parental involvement and increase education about the serious risks and public health problems caused by abuse of alcohol and controlled substances.

Crime and Drug-Related Crime

During 2007, the Drug Enforcement Administration (DEA) made 965 drug arrests in Arizona.¹⁴

- ➤ During FY 2007, Arizona drug apprehension project activities resulted in the arrests of 5,220 drug violators. ¹⁵

Drugs

Cocaine

Cocaine is readily available throughout Arizona while crack is readily available in Arizona's inner cities and in some smaller communities. Powder cocaine retail prices average \$85-\$130/gram and crack retails for an average price of \$10-\$20/rock. On the cocaine retail prices average \$10-\$20/rock.

➤ Heroin²¹

Although heroin is the least abused of all drugs in Arizona, the availability of heroin continues to increase as the demand and distribution networks throughout the U.S. increases. Mexican black tar heroin is the predominant type of heroin found in Arizona.

➤ Marijuana²²

Marijuana remains readily available and is considered the most widely used illegal drug throughout the state. Mexican-produced marijuana retails for \$10-\$25/quarter ounce in the state. Prices for domestically grown plants average approximately \$500/pound.

➤ Methamphetamine²³

Mexican-produced methamphetamine is the predominant form found in Arizona.

- ➤ Pharmaceutical Diversion²⁴
 - Current investigations indicate that diversion of oxycodone and hydrocodone products continues to be a problem in Arizona.
- ➤ According to 2005-2006 data from the National Survey on Drug Use and Health (NSDUH), approximately 395,000 (8%) Arizona citizens (ages 12 or older) reported past month use of an illicit drug.²⁵

- ➤ Approximately 1.89 million (38.72%) Arizona citizens reported that using marijuana occasionally (once a month) was a "great risk". ²⁶
- Additional 2005-2006 NSDUH results indicate that 137,000 (2.81%) Arizona citizens reported illicit drug dependence or abuse within the past year. Approximately 92,000 (1.89%) reported past year illicit drug dependence.²⁷

Juveniles

➤ Approximately 20% of Arizona high school seniors surveyed in 2006 reported lifetime illegal use of prescription drugs. ²⁸

Enforcement

- Arizona Department of Public Safety, Narcotics Enforcement Bureau³¹
 This Bureau provides drug enforcement services statewide through participation in 23 multi-agency task forces. The Narcotics Enforcement Bureau is organized into 3 districts: the Northern Narcotics District in Flagstaff; the Central Narcotics District in Phoenix; and the Southern Narcotics District in Tucson.
- ➤ Joint Drug Intelligence Group (JDIG)³²
 JDIG is a multi-agency drug intelligence task force compiled of investigators and analysts, whose purpose is to proactively collect, evaluate, collate, analyze and disseminate detailed and relevant source information concerning drug trafficking organizations.
- As of October 31, 2006, there were 21,434 full-time law enforcement employees in Arizona (11,932 officers and 9,502 civilians).³³

Trafficking and Seizures

- Arizona is experiencing escalated violence associated with drug and human trafficking along the border. This increasingly violent drug activity is a result of conflict among cartels to control key drug and human smuggling routes into the United States.³⁴
- ➤ United States border communities have become vulnerable to the spill-over of drug related violence from Mexico. Conflicts over control of smuggling routes have expanded drug-related violence to border communities.³⁵
- Arizona's 370-mile border with Mexico consists of sparsely populated areas, vast expanses of rugged mountainous terrain aligned in north-south corridors, and broad valleys and deserts providing unlimited opportunities for drug-related activity. 36
- Major drug smuggling organizations based in Mexico continue to dominate the movement of cocaine, methamphetamine, marijuana and heroin into and through Arizona.³⁷
- ➤ More than 400,000 kilograms of marijuana were seized by Federal agencies in Arizona during 2007. ³⁸

➤ During FY 2007, multi-jurisdictional task forces (MJTF) in Arizona seized 861,692 grams of cocaine. ⁴⁰

Courts

➤ Drug Courts⁴²

As of April 2007, there were 26 drug courts in Arizona that had been operating for at least two years, 5 that had recently been implemented and 8 that were being planned.

- ▶ Drug Prosecution Projects⁴³ During FY 2007, there were 15 drug prosecution projects located throughout Arizona. As a result of the drug prosecution projects' efforts, a total of 24,605 drug violators were convicted in Arizona during FY 2007. More than 62% of the FY 2007 cases were felony convictions.
- ➤ During FY 2006, 30.5% of the Federally-sentenced defendants in Arizona had committed a drug offense. Approximately 73% of these drug cases involved marijuana. 44

Corrections

➤ On February 29, 2008, there were 7,771 prisoners within the Arizona Department of Corrections (DOC) incarcerated for drug offenses. There were also 1,916 offenders under community supervision at that time for drug offenses. ⁴⁵

- During 2006, there were 32,426 drug-related hospital discharges in Arizona.⁴⁷

➤ During 2006, there were 24,360 admissions to drug/alcohol treatment in Arizona. ⁴⁸ There were 28,309 such treatment admissions during 2005. ⁴⁹

According to 2005-2006 NSDUH data, approximately 124,000 (2.53%) Arizona citizens reported needing but not receiving treatment for illicit drug use within the past year.⁵⁰
