Demographics

Programs/Initiatives

- ➤ High Intensity Drug Trafficking Area (HIDTA)⁸
 The Arizona Regional Partnership was designated in 1990 as part of the Southwest Border HIDTA. The Arizona Partnership is responsible for 8 Arizona counties, including Maricopa.
- ➤ Crime Free Multi-Housing Program⁹
 The Phoenix Crime Free Multi-Housing Program was designed to help residents, owners, and managers of rental property keep drugs and other illegal activities off their property. The Phoenix Police Department offers free seminars about the Crime Free Multi-Housing Program to those interested.
- Methamphetamine Community Awareness Program¹⁰
 The Phoenix Police Department Methamphetamine Community Awareness Program "What's Cookin' in Your Neighborhood?" was initiated to educate the public about the methamphetamine problem in the city. The program produced an educational video about how to detect a meth lab and how to respond.

Crime and Drug-Related Crime

From January through November, 2006, there were 8,344 drug offenses known to the Phoenix Police Department. During full year 2005, there were 9,507 drug offenses known to police in Phoenix. 12

From January through November, 2006, there were 213 homicide offenses known to the Phoenix police. ¹³ There were 224 homicides known to police in Phoenix during full year 2005. ¹⁴ There were also 16,255 burglary offenses known to the Phoenix Police Department during full year 2005. ¹⁵

Drugs

Cocaine

Cocaine is consistently available throughout the Phoenix area, ¹⁶ although indicators of abuse suggest that its abuse is decreasing. ¹⁷ Cocaine prices in Phoenix were \$400-600/ounce for powder cocaine and \$600–\$650/ounce for crack cocaine during the first quarter of 2006. A rock of crack sold for \$10-\$20 during that time. ¹⁸

> Heroin

Heroin availability continues to remain high in the Phoenix Metropolitan Area. Throughout 2004, the price of heroin in the area decreased by approximately 40 percent, which indicated an abundance of available heroin. During the last 2 years, purity levels of retail level heroin have increased approximately 7 percent. During the first quarter of 2006, heroin sold for \$50/gram, \$800-\$850/ounce, and \$28,000-\$35,000/kilogram. The Phoenix Division of the DEA is noting the increasing presence of heroin in area public schools. > Marijuana

Marijuana is readily available in large quantities in Phoenix. During the first quarter of 2006, marijuana sold for \$10-\$25/gram, \$75-\$150/ounce and \$500-\$750/pound in Phoenix.²²

> Methamphetamine

Methamphetamine continues to be the apparent drug of choice in the greater Phoenix area. Reported prices for methamphetamine in the Phoenix area have recently decreased. Methamphetamine sold for \$325-\$600/ounce and \$6,500-\$7,500/pound in Phoenix during the first quarter of 2006. At a continuous decreased.

- Club Drugs Treatment programs that serve adolescents reported the continued abuse of GHB, MDMA, LSD, Coricidin HBP.²⁵ During the first quarter of 2006, MDMA tablets sold for \$20-\$30.²⁶
- ➤ Diverted Pharmaceuticals

 The most commonly abused pharmaceutical controlled substances in Phoenix in 2005 included OxyContin (\$20–\$80 per 80-milligram tablet and \$20–\$25 per 40-milligram tablet), Percocet (\$5 per tablet), Vicodin ES (\$5 per tablet), Valium (\$4 per 10-milligram tablet), Lortab (\$5–\$6 per 10-milligram), and Soma (\$2–\$5 per tablet).

- According to 2002-2005 data from the National Survey on Drug Use and Health (NSDUH), approximately 7.6% of Phoenix metropolitan area residents (ages 12 or older) reported past month use of an illicit drug.²⁸

Juveniles

Approximately 26% of the Maricopa County 12th graders surveyed in 2006 reported using a drug within the past month.²⁹

Approximately 11.7% of Maricopa County 8th graders, 18.6% of 10th graders, and 20.1% of 12th graders surveyed in 2006 reported being drunk or high at school within the past year.³¹

Enforcement

- ➤ Drug Enforcement Bureau³²
 - The Drug Enforcement Bureau of the Phoenix Police Department is responsible for the investigation and suppression of illegal drugs in Phoenix. This bureau is also involved in the interdiction of drug trafficking through the Sky Harbor International Airport and shipping facilities throughout the city.
- Commercial Narcotics Interdiction Squad³³ Administered by the Phoenix Police Department, this task force is made up of Federal, State, and local officers organized to identify, arrest, and prosecute drug traffickers using commercial transportation and air freight/parcel companies to transport drugs and money for drug purchases.
- Maricopa County Neighborhood Narcotics Enforcement Team The Maricopa County Neighborhood Narcotics Enforcement Team combines resources of individual agencies in western Maricopa County to combat the increasing gang and narcotic activities in these communities.³⁴
- As of October 2005, there were 3,782 full-time law enforcement employees in Phoenix (2,898 officers and 884 civilians). 35

Trafficking and Seizures

➤ The Phoenix metropolitan area is a major transshipment point for cocaine distribution from Arizona throughout the U.S. ³⁶

- ➤ Phoenix continues to serve as transshipment and distribution points for high purity/low priced Mexican-produced heroin being smuggled to the Pacific Northwest and other areas across the U.S. ³⁷
- Large scale marijuana traffickers utilize tractor-trailers as well as refrigerated utility trailers to transport marijuana through established U. S. routes. Phoenix is commonly used as a stash location until the marijuana is ready to be sent to its final destination.³⁸
- ➤ During FY 2006, the Maricopa County Neighborhood Narcotics Enforcement Team seized more than 13,000 pounds of cannabis. ³⁹

Courts

➤ Drug Courts⁴⁰

As of November, 2006, there were 4 drug courts in Phoenix that had been operating for more than 2 years and 1 drug court that was being planned. There were no additional drug courts in operation or being planned at that time in Phoenix.

➤ Maricopa County Attorney's Office Special Crimes, Gang, Homicide, Trial and Drug Diversion Bureaus⁴¹

The primary objective of this unit is to coordinate and cooperate with all county law enforcement and prosecutorial agencies to increase the apprehension and conviction of drug offenders and seize forfeitable assets. This unit focuses on major, multi-jurisdictional offenders, increased asset seizures, reduction in local user demand for drugs and enhanced operational effectiveness. During FY 2006, this unit concluded 16,976 drug cases.

Corrections

Alpha Substance Abuse Program 42
The Alpha Substance Abuse Program is the inmate substance abuse treatment program for sentenced inmates under the jurisdiction of the Maricopa County Sheriff's Department. Since the Alpha Program began in February 1996, over 700 inmates have successfully graduated and the recidivism rate for Alpha Program graduates is 14%.

Consequences of Use

- ➤ The Phoenix Police Department reported that during the first 6 months of 2005, 115 individuals were murdered in Phoenix. Of these 115 individuals, 38 tested positive for methamphetamine, compared with 26 individuals involved in 110 murders in the first 6 months of 2004. During 2004, the Phoenix Police Department reported 22 individuals were shot by department officers. Of the 22 individuals who were shot, 19 tested positive for methamphetamine. 43
- ➤ The Arizona Attorney General's Office and the Drug Endangered Children's program reported that 408 children were rescued from methamphetamine labs from 2000 to 2005. Of these children, 281 were living in Maricopa County. 44
- ➤ During 2005, there were more than 2,000 emergency department (ED) visits involving methamphetamine in Phoenix.⁴⁵
