Programs/Initiatives

High Intensity Drug Trafficking Area (HIDTA)⁸ The Arizona Partnership, one of the five partnerships of the Southwest Border HIDTA, was designated in 1990 and is responsible for 8 Arizona counties, including Pima County.

Crime and Drug-Related Crime

From January to August 2006, there were 2,636 drug possession offenses reported by the Tucson Police Department. During full year 2005, there were 4,386 such offenses.⁹

Data for 2003 indicate that 73.3% of adult male arrestees and 68.6% of adult female arrestees in Tucson tested positive for at least one of the following drugs at arrest: cocaine, heroin, marijuana, methamphetamine, or PCP.¹²

Percent of Adult Arrestees Testing Positive, Tucson, 2003

Approximately 55% of Tucson's adult male arrestees reported using marijuana in the past year. Among the male arrestees reporting past year marijuana use, the average number of days the drug was used in the past month was 11.6 days.¹³

Approximately 44.1% of Tucson's adult female arrestees reported using marijuana in the past year. Among the female arrestees reporting past year marijuana use, the average number of days the drug was used in the past month was 8.0 days.¹⁴

Results of a survey of Pima County youth indicate that nearly half (45.6%) of high school seniors surveyed in 2004 reported lifetime use of marijuana.¹⁵

- Approximately 9.4% of Pima County high school seniors, 10.1% of tenth graders, and 6.5% of eighth graders surveyed in 2004 reported that they had sold illegal drugs within the past year.¹⁷
- Additionally, 20.9% of seniors, 20.4% of tenth graders, and 14.6% of eighth graders reported being drunk or high at school within the past year.¹⁸

Enforcement

- Counter Narcotics Alliance (CNA)¹⁹ CNA is a multi-jurisdictional, multi-agency narcotics task force in Pima County that is administered by the Tucson Police Department.
- As of October 31, 2004, there were 1,276 full-time law enforcement employees in Tucson (951 officers and 325 civilians).²⁰

Trafficking and Seizures

- Tucson is commonly used as a drug stash location until the substances are ready to be sent to their final destination.²¹
- The Tucson metropolitan area is a major transshipment point for cocaine distribution from Arizona throughout the United States.²²
- During FY 2005, the CNA Task Force seized 101,498 pounds of cannabis. From FY 1988 to FY 2005, the CNA Task Force seized approximately 2,001,628 pounds of cannabis.²³

Courts

 \blacktriangleright Drug Courts²⁴

As of April 14, 2006, there were 2 drug courts in Tucson that had been operating for over 2 years and 1 that was recently implemented. There were no other drug courts in existence or being planned in Tucson at that time.

Pima County Drug Prosecution Project²⁵

Administered by the Pima County Attorney's Office, this program provides prosecution and court litigation services for all law enforcement agencies in Pima County. Since beginning in July 1991, this project has concluded 16,578 cases, which resulted in 13,059 felony and 376 misdemeanor convictions.

- Tucson City Attorney's Drug Enforcement Project²⁶ This program handles all non-felony drug cases referred by the Tucson Police Department's CNA Task Force and the Pima County Attorney's Office, along with asset forfeiture cases. Since July 1991, the activities of this project have resulted in the conclusion of 42,226 drug cases, leading to 27,243 misdemeanor convictions. During FY 2005, 617 offenders were diverted to treatment in lieu of prosecution under this program.
- Approximately 44% of the Pima County Drug Prosecution Project convictions in FY 2005 involved cocaine.²⁷

- > There were 160 drug-induced deaths in Tucson during 2004.²⁸
- > During 2004, there were 173 drug-induced deaths involving Pima County residents.²⁹

Treatment

During 2003, 19.3% of adult male arrestees and 17.7% of adult female arrestees in Tucson reported receiving outpatient substance abuse treatment at some point within their lives.³¹
