The Bankass Milk Processing and Marketing Cooperative ("Bankass Women") is a registered cooperative with 65 members located in the southeastern part of Mopti District, Mali. The Cooperative processes raw milk into pasteurized milk and other dairy products. Bankass Women hopes to take advantage of unmet demand for dairy products in Mali's local and tourism markets. However, Bankass Women is constrained by weak management and marketing, business systems, and unreliable production equipment.

III. Funding

A. ADF Contribution

The financial plan for ADF's contribution is set forth in Appendix A-1 to this agreement. The Parties may make changes to the financial plan without formal amendment, if such changes are made in accordance with Article 7 of the Agreement and do not cause ADF's contribution to exceed the obligated amount specified in Article 4, section 4.1 of the Agreement.
