Ordering

Prior to issuing orders under COMMITS NG, federal contracting officers (COs) must receive training on the use of the COMMITS NG contract and be granted a written delegation of procurement authority from the GWAC program office. Training is offered at no cost via:

- A self-paced, online course at the GSA Center for Acquisition Excellence (available at www.gsa.gov/cae).
