President Bush is Presented A Seven-Year Progress Report On The Success of His Faith-Based and Community Initiative

Below are excerpts taken from the White House Website's <u>Fact Sheet: The Quiet Revolution: A Seven-Year Progress Report</u>

On February 25, 2008, President Bush participated in a briefing on "The Quiet Revolution" report from the White House Office of Faith-Based and Community Initiatives (WHOFBCI). This report, available at www.fbci.gov, offers a portrait of the successful implementation of President Bush's vision to reshape government's approach to addressing human need. By leveling the playing field for faith-based charities and strengthening grassroots nonprofits to effectively help Americans in need, the Faith-Based and Community Initiative is having a tremendous impact on countless lives across our Nation and around the world.



• To further highlight progress under the Faith-Based and Community Initiative, WHOFBCI will sponsor a Conference on Research, Outcomes, and Evaluation, June 26 and 27, in Washington, D.C. This conference will highlight the wide range of research on new initiatives and the changes in governance that have occurred under the Faith-Based and Community Initiative (FBCI) over the past seven years.

FBCI Has Led A Quiet Revolution In The Way Government Addresses Human Need

The FBCI works to place locally-rooted solutions at the center of Federal efforts to help those in need. The Initiative has:

- Removed barriers and launched innovative programs to enable the government to partner with small, community-based nonprofits as never before.
- Established a level playing field for faith-based organizations and set clear, Constitutional guidelines for their use of public funds.
- Delivered in-person training to more than 100,000 social entrepreneurs, by teaching them how to better track their outcomes, write grants, and develop other key skills that help their organizations maximize impact for the people they serve.

Federal competitive awards are expanding the good work of both faith-based and community organizations across America and beyond.

- In 2006 alone, the Federal Government provided more than 18,000 direct, competitive awards to America's nonprofit organizations to aid the homeless, at-risk youth, recovering addicts, returning offenders, AIDS victims, and others.
- These grants totaled more than \$14.7 billion to boost services to people in need. Faith-based organizations were welcomed as a central part of this work, winning more than 3,000 grants in 2006 totaling nearly \$2.2 billion.

<u>Faith-Based And Community Groups Are Supporting The President's Compassion Agenda</u> Around The World

International programs like the President's Emergency Plan for AIDS Relief (PEPFAR), the President's Malaria Initiative, and other U.S.-funded efforts represent massive-scale implementation of the President's vision by empowering both American and indigenous FBCOs. In 2007 alone, approximately 2,213 partners, or 81 percent of partners in PEPFAR's 15 focus countries were indigenous organizations – nearly one-quarter of which were faith-based. These partners have supported 15,000 project sites for prevention, treatment, and care.

The Congressional Quarterly Announced: Compromise Global AIDS Bill Sails Through House Committee

The House Foreign Affairs Committee on Wednesday swiftly approved a bill to reauthorize President Bush's global AIDS program after members of both parties hammered out a compromise late Tuesday. The measure, approved by voice vote, would authorize significantly more funding than Bush requested while easing some of the social policy constraints the White House and Republicans had imposed on the program.

"This bipartisan agreement will greatly facilitate congressional consideration of the vitally important legislation, and I hope and expect that it will be signed into law by President Bush this session of Congress," said acting Chairman .Howard L. Berman, D-Calif.

Republicans and the White House had balked at an earlier Democratic draft that would have made sweeping changes to social policy provisions in the law, which has sent almost \$19 billion overseas to treat AIDS since 2003.

The bill approved Wednesday appeared to satisfy social conservatives and abortion opponents as well as Democrats.

It would replace a current requirement that one-third of all prevention funding go to abstinence education with a requirement for evidence-based, "balanced funding" for abstinence, fidelity and condom programs — the three prongs of traditional HIV prevention strategy. It would require reports to Congress if abstinence and fidelity programs make up less than 50 percent of spending in a given country.

The bill retained a requirement that groups seeking funds under the program have an explicit policy opposing prostitution and sex trafficking.

The compromise would authorize \$50 billion for the program over the next five years, a significant boost from Bush's call for \$30 billion. Democrats, implementing groups and even some Republicans said Bush's amount would merely sustain existing efforts without expanding the program, which provides anti-AIDS drugs to nearly 1.5 million people worldwide.

This year USAID and USDA will be adding a new workshop for faith and community based organizations to their jointly hosted annual International Food Aid Conference. This workshop will be held the morning of April 14 at the Westin Crown Center in Kansas City, Missouri. More than 700 participants, from over 25 countries, are expected to come together from April 14-16, 2008 in Kansas City, Missouri for the tenth annual conference.

USAID to Create Separate Asia Bureau and the Middle East Bureau

On March 2, 2008, the Bureau for Asia and the Near East (ANE) will be divided into two separate, regional bureaus: the Asia Bureau and the Middle East Bureau. These two bureaus have been created in order to enhance oversight and strengthen inter-agency coordination for our programs in these regions.

In addition, the Central Asian Republics(CAR), previously grouped in the Europe & Eurasia (E&E) Bureau, will relocate to the Asia Bureau to better develop a prosperous, stable, and peaceful South and Central Asia region, and to strengthen the north/south ties for Afghanistan north through the Central Asian Republics. The two bureaus will more closely correspond to the Department of State's regional bureau alignment.

USAID has posted a cooperative agreement for US Nongovernmental or Non-US Nongovernmental Organizations that meet Eligibility Requirements as described in the Request For Applications (RFA). The request for applications should focus program objectives to: (1) improve housing through financial services targeted to the poor and very poor in the developing world and (2) through participation in a learning network, generate replicable processes, tools and methodologies for scaling up the housing microfinance sector. Subject to the availability of funds, USAID intends to award approximately 4 to 8 cooperative agreements, valued between \$400,000-\$1.2 Million, for a total value of \$4 Million over a three-year performance period. The overall aim of this program is to contribute to the improvement of the health status of the Malagasy people, especially women and children. This will be accomplished through a social marketing project designed to improve health among key target groups by ensuring widespread access to affordable, high-quality family planning, reproductive health, HIV prevention, malaria prevention and treatment, diarrhea disease prevention and treatment, STI treatment, and safe water treatment products. Special focus will be given to social marketing activities designed to expand the reach of essential health products and services further into rural and underserved areas. The solicitation will also target youth age 15-24 in order to assist them to delay onset of sexual debut, delay pregnancy, and protect themselves from unwanted pregnancy and STIs including HIV. The Department of State has posted a grant, with the intentional of awarding several grants to different organizations, for nonprofits having 501(c)(3) status and private institutions of higher education. They are requesting anti-trafficking in persons proposals for capacity-building programs with locally-based organizations abroad. Programs must include mentoring and partnerships concerning such topics as: developing models for providing comprehensive and effective services for adult and child victims; training initiatives with a focus on identifying and understanding the complex needs of victims; building working relationships with law enforcement responders and other community stakeholders; and, strengthening advocacy skills and public awareness-raising efforts. The Bureau of Cultural and Educational Affairs has posted two grants for nonprofits having 501(c)(3) status and private institutions of higher education. They are seeking proposals to administer this semester-long program for Chilean pre-service teachers. Post-secondary educational institutions may apply independently or in a consortium with other post-secondary institutions. The program will include academic coursework and practicum/student teaching for Chilean EFL student teachers in their penultimate year of undergraduate study. Proposals may include work in the following sectors: protection, health, nutrition, water and sanitation, education, camp management, community services, microenterprise and livelihoods development, humanitarian air services, humanitarian information services, gender-based violence prevention and support, and psychosocial support. Proposed activities should support Liberian refugee reintegration via programs in the health sector (including both physical and mental health). Proposals should target areas of high refugee return (e.g., Lofa County) where refugee returnees make up at least 50% of targeted beneficiaries. Evidence of a well-developed transition/exit strategy from the project activity will be especially important. Priority will be given to proposals from organizations that can demonstrate: (1) a working relationship with UNHCR and 2008 UNHCR funding and/or support for the proposed activities and/or overall country program; (2) a proven track record in providing proposed assistance (both in the health sector and specified location) to Liberian refugee returnees; (3) evidence of coordination with development organizations and/or host government entities that could take on support of any ongoing efforts; and (4) appropriate targeting of beneficiaries in coordination with UNHCR and other relevant organizations.
