

STANDARD OF THE MONTH

PROFESSIONAL JUDGMENT

Periodically, we highlight a standard from the President's Council on Integrity and Efficiency's Quality Standards for Inspections. This encourages the consistent application of these standards throughout the Inspector General community.

Maintaining professional judgment means maintaining integrity, objectivity, and independence. Professional judgment requires the exercise of professional skepticism by questioning and assessing all evidence.

The following should be considered when using professional judgment:

1. Work should be in accordance with all applicable laws, rules, and regulations.
2. Work should be timely and complete, using appropriate methods and techniques.
3. Evidence is gathered and reported in an independent manner and report findings can be supported.
4. OIG staff coordinates inspection results with appropriate officials.
