Mr. Hancock,

The purpose of this letter is to document the audit of the Technical Data Package (TDP) in accordance with your 20 November 2008 letter providing instruction on the reuse of testing for the Premier certification effort. iBeta has completed the instructed audit of the Technical Data Package (TDP) submitted to and reviewed by SysTest. This letter also provides the iBeta recommendation to the EAC regarding the reuse of the TDP review conducted by SysTest.

Documentation of the Audit of the TDP

To conduct the audit, iBeta utilized our internal Quality Management System (QMS) PCA Document Review Procedure Version 2.0 and selected a sampling of the full Premier AssureTM 1.2 TDP. The documents selected for the sampling (as listed in Attachment 1) provided review and audit of each product as well as coverage of each section in the VSS Volume 2 TDP requirements.

A review sheet was created from the iBeta controlled template for each section and controlled within SharePoint within the Premier Project. Document reviewers, all with previous experience conducting PCA Document Reviews on other certification efforts, were assigned. The reviews were conducted in accordance with the instructions within the procedure and template. Upon completion of the review, each review was then a peer reviewed. The status of the review as well as the peer was tracked in the Status Report - PCA Document Review spreadsheet and is provided as Attachment 2 to this letter.

No discrepancies were written as a result of the review and audit.

Recommendation regarding the need to conduct a full review of the TDP

The iBeta recommendation based on the audit and review as documented herein is that the results of the SysTest PCA Document Review are adequate for reuse in the Premier Assure 1.2 certification test effort and there is not a need to conduct a full review of the TDP. Based on the 20 November 2008 letter, iBeta will proceed with the certification test effort once the EAC makes a determination on the reuse of the TDP review conducted by SysTest.
