Why Partner Of The Year



- Recognition is key element of energy management
- External recognition helps to elevate energy and validate its importance



Types Of Recognition



Award Applications

- Leadership in Energy Management
- Excellence in Promoting Superior Energy Performance

Award Categories

- Partner of the Year
- Corporate Commitment
- Sustained Excellence



Awards are given only if EPA receives qualified applications.

Review Process



- Reviewed by Sector and Account Managers
- Recommendations are made to Selection Committee.
- Selection Committee reviews all applications, recommendations, and deliberates.
- Award winners are chosen and notified by phone & mail

What We Look For In An Application



- <u>Demonstration</u> show your organization's commitment to and success in managing energy & protecting the environment
- <u>Completeness</u> address all requested items in the application and explain carefully
- Adherence please follow directions
 - no more than 12 pages for written text
 - answer all questions
- The best of the best, of course!

Let's Look At An Example



- Section 3 Energy Benchmarking,
 Part A Organizational Approach
 - How energy is tracked what is tracked? what data is benchmarked? across facilities? across company? source of data? metering? real-time? who's involved? Submit an example
 - How data is used who sees it? how does it impact decisions? how does it fit into the energy management plan? how do managers use it?
 - <u>Value</u> what is your organizational philosophy of benchmarking? is it a fundamental part of energy management? how does it impact decisions?

Tips For Completing The Application



- Read the Guidelines for Energy
 Management. See if your program has the elements of corporate energy management. See Energy Star website.
- Take the test. Review your energy practices against those in the Guidelines by filling out the Matrix, a selfassessment tool.

Questions From Partners



- What do we want to see in the Benchmarking section? Everything we ask for that applies to your organization.
- Do I really have to provide this or that? Yes, please address the requested items.
- Can I provide supporting materials? Yes, please provide examples as an attachment.
- Can I send the application in a few days late? No. We really hold to the postmarked and emailed date of 12/15/04.

Areas For Improvement



- <u>Communications</u> activities have been limited
 - Partners agree to educate staff and public about ENERGY STAR & energy efficiency
 - Internal and external communications
- Benchmarking unclear and incomplete tables
- Continuing improvement show how it progresses from previous years
- Specific improvement projects tell us what you did in the past year – not 5 or 10 years ago

Awards Ceremony



- EPA and DOE recognize POY winners that demonstrate superior energy performance and environmental leadership.
 - Annual spring awards ceremony
 - POY winners encouraged to highlight their achievements
 - Audience members include high-level EPA and DOE officials, corporate executives, and the media
