Re: Supplement to Joint Applications of OnePoint Communications Corp. and Verizon Communications for Authority to Transfer Control of Section 214 Authorizations to Provide Domestic Interstate and International Telecommunications Services as a Non-Dominant Carrier

Dear Ms. Salas:

Pursuant to the request of the Commission staff, this letter clarifies OnePoint's current wireless holdings. As the Commission is aware, OnePoint has sought and received Commission authority to assign virtually all of its wireless licenses to 21st Century Cable II of Chicago, Inc. (file nos. 0000180235 and 0000211852). That transaction was consummated on September 11, 2000¹ and Notices of Consumation (File No. 217442 and 217443) were filed electronically on September 12, 2000. Form 312 was hand delivered to the Commission to note the assignment of Receive Only Registration E990040 to 21st Century. OnePoint also recently turned several other licenses in to the Commission for cancellation (call signs WPJB917, WPJD408, WPOR611, and WPOR612).

¹ For one of the call signs assigned, WPNB783, there is currently pending an application for modification of license (File No. 168104). The underlying license has been assigned to 21st Century. The FCC staff has advised OnePoint that the modification application must stay in OnePoint's name until granted at which point the modification will automatically be transferred to 21st Century.

Accordingly, OnePoint currently holds only one wireless license, private microwave call sign WPQS217, as a result of the recent grant of an application for a new station license (file no. 0000069231). On September 13, 2000, OnePoint electronically filed an application seeking consent to the assignment of that license to 21st Century Cable TV of Chicago, Inc., a subsidiary of RCN (file no. 0000218082). That application remains pending. However, it is anticipated that the assignment to 21st Century will be consummated prior to the proposed transaction with Verizon. OnePoint also currently has pending one other application – one for a new station license (file no. 0000168834). This facility will also ultimately be assigned to 21st Century, after grant of the license to OnePoint by the Commission.
