In accordance with Section 1.1206 of the Commission's Rules, 47 C.F.R. § 1.1206, notice is hereby given of an oral *ex parte* presentation regarding the above-captioned proceeding. On January 26, 2001, Mary Brooner and Ron Barky of Motorola, Laura Holloway of Nextel, and I met with members of the Wireless Telecommunications Bureau and the Office of General Counsel to discuss the above-mentioned transaction. The specific Commission staff members present at the meeting were Lauren Kravetz, John Branscome, and Monica Desai of the Wireless Telecommunications Bureau's Commercial Wireless Division; Susan Singer, Economist, Wireless Telecommunications Bureau; and Joel Rabinovitz, Neil Dellar, and Pieter van Leeuwen of the Office of General Counsel. The purpose of the meeting was to discuss the status of the proposed transaction and the positions of Motorola and Nextel as expressed in various filings with the Commission, including the parties' September 23, 2000, application package and comments filed separately by both entities on November 30, 2000. No new arguments or positions not mentioned in these pending pleadings were discussed, and no written materials were presented or left with the Commission staff.
