SUBJECT: DEFENSE BASE ACT (DBA) WAIVER LIST

CONTRACT INFORMATION BULLETIN 96 - 20

This CIB supersedes 95-13.

A waiver from Defense Base Act insurance may be issued for foreign citizens. Foreign national employees covered by this waiver are exempt from the requirement to secure Defense Base Act Insurance but must be provided worker's compensation benefits as prescribed in applicable foreign laws. However, the waiver does not apply to any employee who is:

1. Hired in the United States by any contractor;
2. A resident of the United States; or,
3. A citizen of the United States.

ALL U.S. CITIZENS, ALL U.S. RESIDENTS AND ANYONE HIRED IN THE U.S. MUST BE PROVIDED WITH DBA INSURANCE FOR ANY PERIOD OF TIME THEY ARE EMPLOYED OVERSEAS.

The only change to the attached list is to add Yemen which was inadvertently dropped from the previous list.
