SIXTY INDIVIDUALS INDICTED ON FEDERAL CHARGES FOLLOWING UNDERCOVER STOREFRONT INVESTIGATION

STATESBORO, Ga. – Edmund A. Booth, Jr., United States Attorney for the Southern District of Georgia, announced that a federal grand jury during the months of March and April, returned 34 indictments against 60 defendants, for a combined total of 425 counts related primarily to firearm and drug offenses. There are some charges involving false statements to Georgia Medicaid.

Booth stated that the indictments stem from a 10-month undercover operation, dubbed "Statesboro Blues," conducted in Statesboro, Georgia. The Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) initiated the investigation in the summer of 2008, in conjunction with the Statesboro Police Department. Later, United States Immigration and Customs Enforcement, United States Secret Service, and the Multi-Agency Crack Enforcement Drug Task Force of Hinesville, Georgia, joined in the operation, bringing additional resources and personnel to assist in the effort. Investigative support into health care fraud matters was provided by the Georgia Department of Audits and the Georgia Department of Community Health.

Booth noted that ATF undercover agents made contacts with multiple suspects, several of them associated with local street gangs, and purchased illegal drugs and firearms.

During the undercover operation, ATF agents purchased 96 crime guns, to include handguns, rifles, assault rifles, shotguns and sawed-off shotguns, along with illegal drugs. A number of the guns had been stolen in burglaries of homes. In addition, the investigation revealed that some of the individuals who sold firearms in the storefront were felons having previous convictions for violent offenses, including assault, robbery, burglary, narcotics trafficking and firearms violations. As a result of the investigative efforts of the undercover agents and officers, evidence was gathered solving an aggravated assault and a burglary in Bulloch County which previously had been unsolved. The investigation also led to the indictment of more than 30 offenders by the Bulloch County Grand Jury for state firearms and drug charges.

In commenting on the operation, Booth said "this undercover operation was highly successful and is a prime example of exceptional cooperation between federal and local law enforcement in addressing violent crime and gang related activities in this community." Both Police Chief Stan York and ATF Special Agent in Charge Gregory K. Gant agreed. York stated that "we will stay committed to addressing all illegal gang activities, especially of those that think violence is an acceptable way of life. We will continue to work to take criminals off our streets." According to Gant, "with this investigation culminating in our law enforcement action today, we have taken numerous crime guns off of the streets. These guns will no longer fuel violence in this community, nor will those who possessed them be able to destroy communities or impact families".

Booth commended the dedication, service and exemplary working partnership between the Statesboro Police Department and the Bureau of Alcohol, Tobacco, Firearms, and Explosives throughout the investigation.

Booth stressed that an indictment is only an accusation and is not evidence of guilt. All defendants are entitled to a fair trial, during which it will be the Government's burden to prove guilt beyond a reasonable doubt. Initial appearances for the federally indicted defendants will be held in United States District Court, Statesboro, Georgia, at 11:00 a.m. and 3:00 p.m. on April 16, 2009.
