ATF ENTERS INVESTIGATION INTO FIRE AT QUALITY TRAILER PRODUCTS DISTRIBUTION PLANT

DALLAS - The National Response Team from the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) along with ATF special agents from Dallas and Fort Worth, Texas have entered the investigation of a large commercial fire that occurred February 22nd at the Quality Trailer Products Distribution Plant in Azle, Texas.

Ken Chisholm, Assistant Special Agent in Charge of ATF Dallas, said “the plant stores and distributes parts used to build trailers and damage was estimated at approximately \$2.5 million. Two firefighters were slightly injured battling the blaze. ATF is assisting the Azle Fire Department and the Azle Fire Marshal’s Office in the joint investigation.” The National Response Team is being brought in to assist in the investigation because of the difficulties presented when investigating a fire of this size.

In 1978, ATF developed the NRT to assist federal, state and local investigators in meeting the challenges faced at the scenes of significant arson and explosives incidents. The NRT consists of four teams organized geographically to cover the United States. Each team can respond within 24 hours to assist state and local law enforcement/fire service personnel in onsite investigations.

In addition to investigating hundreds of large fire scenes, the NRT has also been activated to scenes such as the 1993 World Trade Center bombing, the Oklahoma City Federal Building bombing and the 9/11 Pentagon crash site, as well as explosions at explosives and ammunition manufacturing plants, legal fireworks factories and illegal explosive device manufacturing operations.

The teams are each composed of veteran special agents who have post blast and fire origin-and-cause expertise; forensic chemists; explosives enforcement officers; fire protection engineers; accelerant detection canines; explosives detection canines; intelligence support, computer forensic support and audit support. The teams work alongside state and local officers in reconstructing the scene, identifying the seat of the blast or origin of the fire, conducting interviews, and sifting through debris to obtain evidence related to the bombing/arson.

Further complementing the team's efforts are technical, legal and intelligence advisers. Moreover, a fleet of fully equipped response vehicles strategically located throughout the United States is available to provide logistical support.

The NRT will be on the scene of the fire beginning this morning. This will be the NRT's ninth activation for fiscal year 2008 and the 650th activation since the inception of the NRT in 1978.
