## UNITED STATES ATTORNEY REPORTS WEEKLY RESULTS OF ST. LOUIS REGIONAL CEASEFIRE INITIATIVE

St. Louis, Missouri: The following represents the prosecution activities under the St. Louis Regional Ceasefire Initiative, a component of the Bush Administration's Project Safe Neighborhoods Program, United States Attorney James G. Martin announced today.

These cases are the result of the collaborative efforts of federal and local law enforcement including the U.S. Attorney's Office, the St. Louis City Circuit Attorney's Office, the St. Louis County Prosecutor's Office, the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), the U.S. Marshal's Service, the Drug Enforcement Administration, the St. Louis Metropolitan Police Department and the St. Louis County Police Department.

This week's results of Project Safe Neighborhood/Ceasefire are as follows:

## **UNITED STATES ATTORNEY'S OFFICE**

JOHN PETER SPUDICH, 56, of the 6500 block of Nashville, St. Louis was sentenced to 60 months in prison, without parole, on one felony count of being a previously convicted felon in possession of a firearm.

DWIGHT RHODES, 29, of the 9600 block of Baltimore, St. Louis, 63114, was sentenced to 76 months in prison, without parole, on one felony count of being a previously convicted felon in possession of a firearm.

WILLIAM LUX, 33, of the 600 block of Woodview, Villa Ridge, Missouri, was sentenced to 50 months in prison, without parole, on one felony count of possession of an unregistered firearm.

JAMES D. WOOLFOLK, JR., 29, of the 4700 block of Lee, St. Louis, 63115, was sentenced to 18 months in prison, without parole on one felony count of possession of a unregistered sawed-off shotgun.

DONOVAN MONTELL BAUCOM, 41, of the 3800 block of Philbrook, Pine Lawn, 63121, was sentenced to 42 months in prison on one felony count of being a previously convicted felon in possession of a firearm.

DARRELL L. WELLS, 29, of the 1100 block of Wilson, University City, 63130, was sentenced to 30 months in prison, without parole, on one felony count of being a previously convicted felon in possession of a firearm.

TERRY NEBBITT, 29, of the 5600 block of Vernon, St. Louis, 63122, was sentenced to eight months in prison, without parole, on one felony count of possession of a firearm in a school zone.

SHEADRICK INGRAM, 32, of the 800 block of Edna, St. Louis, was sentenced to 27 months in prison, without parole, on one felony count of being a previously convicted felon in possession of a firearm.

DARRYLE L. MOTT, 33, of the 10800 block of Linnell Drive, St. Louis, 63136, pled guilty to one felony count of being a felon in possession of a firearm. Mott now faces a maximum penalty of ten years in prison and/or a fine of \$250,000. Sentencing has been set for February 11, 2004.
