## ST. LOUIS CIRCUIT ATTORNEY AND UNITED STATES ATTORNEY REPORT WEEKLY RESULTS OF ST. LOUIS REGIONAL CEASEFIRE INITIATIVE

St. Louis, Missouri: The following represents the prosecution activities under the St. Louis Regional Ceasefire Initiative, a component of the Bush Administration's Project Safe Neighborhoods Program, United States Attorney James G. Martin and St. Louis Circuit Attorney Jennifer Joyce announced today.

These cases are the result of the collaborative efforts of federal and local law enforcement including the U.S. Attorney's Office, the St. Louis City Circuit Attorney's Office, the St. Louis County Prosecutor's Office, the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), the U.S. Marshal's Service, the Drug Enforcement Administration, the St. Louis Metropolitan Police Department and the St. Louis County Police Department.

This week's results of Project Safe Neighborhood/Ceasefire are as follows:

## ST. LOUIS CIRCUIT ATTORNEY'S OFFICE:

Christopher Toliver, 26, of the 3800 block of Greer, was sentenced to serve 12 years in the Missouri Department of Corrections for robbery first degree, 15 years in the Missouri Department of Corrections for two counts of possession of a controlled substance, and 7 years in the Missouri Department of Corrections for unlawful use of a weapon, resisting arrest, and leaving the scene of an accident. Toliver's sentences were imposed by Judge Phillip Heagney on December 21, 2004. The Judge ordered that Toliver first serve his robbery sentence before beginning service on the remaining sentences.

## **UNITED STATES ATTORNEY'S OFFICE**

TODD SCOTT, 30, of the 7500 block of Virginia, St. Louis, 63111, was sentenced to 56 months in prison, without parole, on one felony count of being a previously convicted felon in possession of a firearm.

DIALLO DAVIDSON, 31, of the 200 block of Tippen, Ferguson, Missouri was sentenced to 96 months in prison, without parole, one felony count of being a previously convicted felon in possession of a firearm.

JEROME GREEN, 25, of the 2600 block of Armand Place, St. Louis, 63104, was sentenced to 60 months in prison, without parole, on one felony count of possession of a firearm in furtherance of a drug trafficking crime.

RONALD SEALS, 33, of the 3800 block of Lafayette, St. Louis, 63110, was sentenced to 63 months in prison, without parole on one felony count of being a previously convicted felon in possession of a firearm.

TERROLL MOSS, 37, of the 10,000 block of St. Cosma, St. Louis, pled guilty to one felony count of being a previously convicted felon in possession of a firearm. Moss now faces a maximum penalty of ten years in prison and/or a fine of \$250,000. Sentencing has been set for April 1, 2005.

SHAWN HINES, 21, of the 5100 block of Robin, St. Louis, pled guilty to one felony count of being a previously convicted felon in possession of a firearm. Hines now faces a maximum penalty of ten years in prison and/or a fine of \$250,000. Sentencing has been set for April 1, 2005.

JEROME T. MCDANIELS, 27, of the 6200 block of Ridge, St. Louis, 63136, was indicted by a federal grand jury on one felony count of being a previously convicted felon in possession of a firearm. If convicted, McDaniels faces a penalty range of 15 years to life in prison.

REGINALD CARTEZ HALL, 20, of the 1200 block of Gamblin, St. Louis, 63147, was indicted by a federal grand jury on one felony count of being a previously convicted felon in possession of a firearm. If convicted, Hall faces a penalty of 10 years in prison and/or a fine of \$250,000.

The charges set forth in an indictment are merely accusations, and each defendant is presumed innocent until and unless proven guilty.
