PROJECT CEASEFIRE

TWO KC MEN, ONE INDEPENDENCE MAN INDICTED FOR ILLEGALLY POSSESSING FIREARMS

KANSAS CITY, Mo. – Todd P. Graves, United States Attorney for the Western District of Missouri, announced today that three felons were indicted by a federal grand jury, in separate and unrelated cases, for illegally possessing firearms.

The indictments were returned by a federal grand jury on Jan. 24, 2005, and are part of Project Ceasefire, the district's ongoing anti-crime initiative.

* William R. Wilson, 43, of Kansas City, Mo., was charged in an indictment returned by a federal grand jury in Kansas City with being a felon in possession of a firearm.

The federal indictment alleges that **Wilson** was in possession of a New England Arms 20-gauge shotgun on Jan. 18, 2005. Under federal law, Graves explained, it is illegal for anyone who has been convicted of a felony to be in possession of any firearm or ammunition. **Wilson** has a 1991 criminal felony conviction for stealing in Jackson County, Mo.

This case is being prosecuted by Assistant U.S. Attorney David A. Barnes. It was investigated by the Bureau of Alcohol, Tobacco, Firearms and Explosives.

* Michael J. Miller, 43, of Independence, Mo., was charged in an indictment returned by a federal grand jury in Kansas City with being a felon in possession of a firearm.

The federal indictment alleges that **Miller** was in possession of a RG Industries .22-caliber revolver on Jan. 20, 2005. Under federal law, Graves explained, it is illegal for anyone who has been convicted of a felony to be in possession of any firearm or ammunition. **Miller** has a 1994 and a 2000 criminal felony conviction for driving under the influence.

This case is being prosecuted by Assistant U.S. Attorney David A. Barnes. It was investigated by the Bureau of Alcohol, Tobacco, Firearms and Explosives.

* Walter L. Morris, 24, of Kansas City, Mo., was charged in an indictment returned by a federal grand jury in Kansas City with being a felon in possession of a firearm.

The federal indictment alleges that **Morris** was in possession of a Zastava rifle on Jan. 21, 2005. Under federal law, Graves explained, it is illegal for anyone who has been convicted of a felony to be in possession of any firearm or ammunition. **Morris** has a 2000 criminal felony conviction for attempted burglary.

This case is being prosecuted by Assistant U.S. Attorney Christina Y. Tabor. It was investigated by the Kansas City, Mo., Police Department and the Bureau of Alcohol, Tobacco, Firearms and Explosives.

Graves cautioned that the charges contained in these indictments are simply accusations and not evidence of guilt. Evidence supporting the charges must be presented to a federal trial jury, whose duty is to determine guilt or innocence.

Project Ceasefire

Project Ceasefire, launched in October 1999, is a cooperative initiative by federal and local law enforcement and the Kansas City Crime Commission that targets for federal prosecution persons who unlawfully use or possess firearms.
