
WASTEWISE CLIMATE CAMPAIGN



POUNDS OF WASTE REDUCED BY WASTEWISE PARTNERS



COST SAVINGS EXAMPLES

Allergan, Inc. collected 2,271 tons of materials for recycling—bringing in \$264,000 in revenue and saving an estimated \$100,000 in disposal costs.


General Motors (GM) saved more than \$400,000 by preventing waste through reusing materials, training employees, making processes more efficient, and reducing the use of certain materials.

Public Service Enterprise Group (PSEG) saved nearly \$280,000 by avoiding disposal costs for recycled paints, resins, batteries, and computer cartridges. The company also earned \$1.4 million from the sale of recycled materials.

GHG EMISSION REDUCTIONS



GHG EMISSION REDUCTIONS

EXAMPLES


The University of Miami collected more than 7 tons of books through a recycling campaign. By recycling them, the university reduced GHG emissions by 6 MTCE—equivalent to the emissions from using 50 barrels of crude oil.

The City of Clifton, New Jersey's grass and food waste composting program alone reduces GHG emissions by 775 MTCE each year—equivalent to more than 580 cars' emissions for one year.

The Seydel Companies recycled 813 tons of HDPE plastic, which reduced GHG emissions by approximately 312 MTCE—equivalent to the carbon sequestration of 8,000 tree seedlings grown for 10 years.


