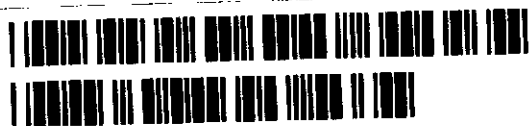

JOINT STIPULATION OF  
SETTLEMENT RE:  
ATTORNEY'S FEES AND COSTS


The substance of this action having been settled fully by the agreement filed concurrently herewith, plaintiffs and defendants, by and through their undersigned counsel, hereby agree and stipulate to settle plaintiffs' claims for attorney's fees and costs incurred in this action as follows:


1. Defendants will pay Plaintiffs \$1,775,000 in full settlement of all claims they may have for attorneys' fees, plus costs to be itemized and not to exceed \$35,000, whether under the Equal Access to Justice Act ("EAJA") 28 U.S.C. § 2412(d), or otherwise, provided that the Court approves the stipulation for settlement of the merits filed concurrently herewith, and final judgment is entered not subject to appeal or termination. In the event the Court declines to approve the stipulation for settlement of the merits filed concurrently herewith, this stipulation shall be null and void.

2. Attorneys fees and costs under this agreement shall be made payable to Gibbs, Houston & Pauw, 1000 Second Ave. Suite 1600, Seattle, WA 98104, and such payment will release Defendants from all payment obligations to Plaintiffs under EAJA and any other applicable law or regulation.


