UNANIMOUS CONSENT AGREEMENTS

S. 2663 (ORDER NO. 582)

1.—Ordered, That on Thursday, March 6, 2008, upon the conclusion of Morning Business, the Senate resume consideration of S. 2663, a bill to reform the Consumer Product Safety Commission to provide greater protection for children's products, to improve the screening of noncompliant consumer products, to improve the effectiveness of consumer product recall programs, and for other purposes. Ordered further, That the Senate resume consideration of Amdt. No. 4097, offered by the Senator from Louisiana (Mr. Vitter), with 15 minutes of debate prior to a vote

Ordered further, That the Senate resume consideration of Amdt. No. 4097, offered by the Senator from Louisiana (Mr. Vitter), with 15 minutes of debate prior to a vote in relation to the amendment, with the time equally divided and controlled between the Senator from Arkansas (Mr. Pryor) and the Senator from Louisiana (Mr. Vitter) or their designees; provided, that upon the use or yielding back of time, the Senate proceed to vote in relation to the amendment, with no amendments in order to the amendment prior to the vote.

Ordered further, That with regard to the cloture motion, the mandatory quorum required under Rule XXII be waived. (Mar. 5, 2008.)

FISCAL YEAR 2009 BUDGET RESOLUTION

2.—Ordered, That notwithstanding Rule XXVI, paragraph 7 of the Standing Rules of the Senate, and Rule III of the Senate Budget Committee Rules, that any member of the Committee be permitted to vote by proxy, with the concurrence of the Chair and Ranking Member of the Committee, at the meeting of the Senate Budget Committee on March 6, 2008; provided, that any vote cast on behalf of that member, by proxy in the Budget Committee on that date, be treated by the Committee as if that member were physically present, but the proxy not count for the purposes of establishing a quorum present; provided further, that if the Budget Committee orders reported a concurrent resolution on the budget for fiscal year 2009 on that date, such measure be deemed to have been ordered reported in compliance with Rule XXVI, paragraph 7 of the Standing Rules of the Senate, and the rules of the Senate Budget Committee. (Mar. 4, 2008.)

S. 1974

3.—Ordered, That upon passage of S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, the bill remain at the desk until such time as the Senate receives a companion measure from the House.

Ordered further, That when the Senate receives a companion measure from the House, the Senate then proceed to its consideration; provided, that all after the enacting clause be stricken and the text of S. 1974, as amended, be inserted, in lieu thereof; provided further, that the bill be read a third time, passed and the motion to reconsider be considered made and laid upon the table without further intervening action or debate, and that S. 1974 then be returned to the calendar. (Dec. 19, 2007.)

S. 2483 (ORDER NO. 546)

4.—Ordered, That at a time to be determined by the Majority Leader, following consultation with the Republican Leader, the Senate proceed to the consideration of S. 2483, a bill to authorize certain programs and activities in the Forest Service, the Department of the Interior, and the Department of Energy, and for other purposes.

Ordered further, That it be considered under the following limitations: that the only amendments in order be five related amendments to be offered by the Senator from Oklahoma (Mr. Coburn), and that upon disposition of all amendments, the bill be read a third time, and the Senate proceed to vote in the passage of the bill. (Dec. 19, 2007.)

VETO MESSAGE ON S. 5

5.—Ordered, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (June 20, 2007.)

H.R. 3997

6.—Ordered, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance. (Dec. 12, 19, 2007.)
