**UNANIMOUS CONSENT AGREEMENTS**

S. 1974

1.—*Ordered*, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (*Mar. 31, 2008.*)

VETO MESSAGE ON S. 5

2.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

*Ordered further*, That the message be held at the desk. (*June 20, 2007.*)

H.R. 3997

3.—*Ordered*, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance. (*Dec. 12, 19, 2007.*)

When objection is heard to immediate consideration of a resolution or motion when submitted, it shall be placed here, to be laid before the Senate on the next legislative day for consideration, unless by unanimous consent the Senate shall otherwise direct. (Rule XIV, Paragraph 6.)
