UNANIMOUS CONSENT AGREEMENTS

HOUSE MESSAGE ON H.R. 2642

1.—*Ordered*, That following any Leader time on Thursday, May 22, 2008, the Senate resume the message from the House on H.R. 2642, an act making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2008, and for other purposes, and there be 2 hours of debate equally divided and controlled between the Leaders or their designees; provided, that upon the use or yielding back of time, the cloture motion with respect to the motion to concur in House Amdt. No. 2 with Amdt. No. 4803 be withdrawn, Amdt. No. 4804 also be withdrawn, and the Senate then proceed to vote on adoption of the motion to concur with an amendment in House Amdt. No. 2 with Amdt. No. 4803; provided further, that the motion to concur be subject to an affirmative 60 vote threshold; further, that if the motion achieves that threshold, it be agreed to and the motion to reconsider be considered made and laid upon the table.

Ordered further, That if the motion fails to achieve the 60 vote threshold, it be withdrawn, and the Senator from Nevada (Mr. Reid) be recognized to move to concur in House Amdt. No. 2 with an amendment which is the text of the Webb GI bill; provided, that the motion be subject to an affirmative 60 vote threshold, and that if it achieves that threshold, the motion to concur with an amendment be agreed to and the motion to reconsider be made and laid upon the table; provided further, that if the motion fails to achieve 60 affirmative votes, it be withdrawn, and the Senate disagree to House Amdt. No. 2.

Ordered further, That upon disposition of House Amdt. No. 2, the Senator from Nevada (Mr. Reid) be recognized to move to concur in House Amdt. No. 1 with an amendment which is the text of the Committee-reported Amdt. Nos. 2 and 3 on Iraq policy and funding; provided, that the Senator from Vermont (Mr. Sanders) then be recognized to make a Rule XVI point of order against Section 11312 of the motion to concur in House Amdt. No. 1 with an amendment; provided further, that if the point of order is sustained, the Senator from Nevada (Mr. Reid) be recognized to move to concur in House Amdt. No. 1 with an amendment which is the text of Committee-reported Amdt. Nos. 2 and 3 without section 11312; further, that the motion be subject to a 60 affirmative vote threshold, and that if it achieves that threshold, it be agreed to, and the motion to reconsider be considered made and laid upon the table.

Ordered further, That if the motion fails to achieve the 60 vote threshold, it be withdrawn, and the Senator from Nevada (Mr. Reid) be recognized to move to concur in House Amdt. No. 1 with an amendment which is the text of Committee Amdt. No. 2 without section 11312; provided, that the motion be subject to an affirmative 60 vote threshold, and that if the motion achieves that threshold, it be agreed to, and the motion to reconsider be considered made and laid upon the table; provided further, that if the motion fails to achieve that threshold, then it be withdrawn, and the Senate disagree to House Amdt. No. 1; further, that no further points of order be in order, with no intervening action or debate. (*May 21, 2008.*)

S. 1974

2.—*Ordered*, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (*Mar. 31, 2008.*)

VETO MESSAGE ON S. 5

3.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (*June 20, 2007.*)

H.R. 3997

4.—*Ordered*, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance. (*Dec. 12, 19, 2007.*)
