UNANIMOUS CONSENT AGREEMENTS

H.R. 976 (ORDER NO. 58)

1.—*Ordered*, That on Wednesday, August 1, 2007, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to H.R. 976, an act to amend the Internal Revenue Code of 1986 to provide tax relief for small businesses, and for other purposes; provided, that there then be 30 minutes of debate on Amdt. No. 2538, offered by the Senator from Nevada (Mr. Ensign) with the time equally divided between the Senator from Nevada and the Senator from Montana (Mr. Baucus) or their designees, and that upon the use or yielding back of time the Senate proceed to a vote in relation to the amendment.

Ordered further, That no second degree amendments be in order to the amendment prior to the vote. (*July 31, 2007.*)

HOUSE MESSAGE ON S. 1

2.—*Ordered*, That the mandatory quorum call under Rule XXII be waived with respect to the cloture motion filed on the motion to concur in the amendment of the House to S. 1, an act to provide greater transparency in the legislative process. (*July 31, 2007.*)

VETO MESSAGE ON S. 5

3.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (*June 20, 2007.*)
