UNANIMOUS CONSENT AGREEMENTS

H.R. 2 (ORDER NO. 5)

1.—*Ordered*, That on Thursday, February 1, 2007, upon the conclusion of Executive Session, the Senate resume consideration of H.R. 2, an Act to amend the Fair Labor Standards Act of 1938 to provide for an increase in the Federal minimum wage; provided that all time during the adjournment of the Senate and all time consumed during Morning Business and Executive Session on February 1, 2007, count against the time post-cloture. (*January 31, 2007.*)

S. CON. RES. 2 (ORDER NO. 12)

2.—*Ordered*, That with respect to the cloture motion filed on the motion to proceed to S. Con. Res. 2, a concurrent resolution expressing the bipartisan resolution on Iraq, the mandatory quorum call be waived. (*Jan. 26, 2007.*)
